on the opening, allocation and management of the Community
tariff quota in 1982 for frozen beef and veal

Subject: Report on the opening, allocation and management of the Community tariff quota in 1982 for frozen beef and veal

Article 6 of Council Regulation (EEC) No 136/82 of 19 January 1982, opening, allocating and providing for the administration of a Community tariff quota for frozen beef and veal falling within subheading 02.01 A II b) of the common customs tariff (1982) (1), provides that the Commission shall, not later than 1 October 1982, submit to the Council a report on the quantities for which licences have been issued in each Member State and that the Council, acting by a qualified majority on a proposal from the Commission, shall reallocate any unused quantities.

The information at present available to the Commission shows that :

- during the period 1 January to 31 July 1982 licences have been actually issued for a total of 33 341 tonnes, expressed in bone-in meat, namely 51.3% of the total quantities provided for; if the quantity allocated to Italy is not taken into account for this calculation, this latter figure becomes 72.1%;
- the actual granting of licences in 1982 has been characterized by a substantial administrative delay in Italy;
- at the meeting of the Management Committee for Beef and Veal held the 10.9.1982, representatives of the Member States stated that the licences for the quantity outstanding would be issued between now and the end of the year.

For these reasons the Commission considers it unnecessary to make any reallocation of the quota.
