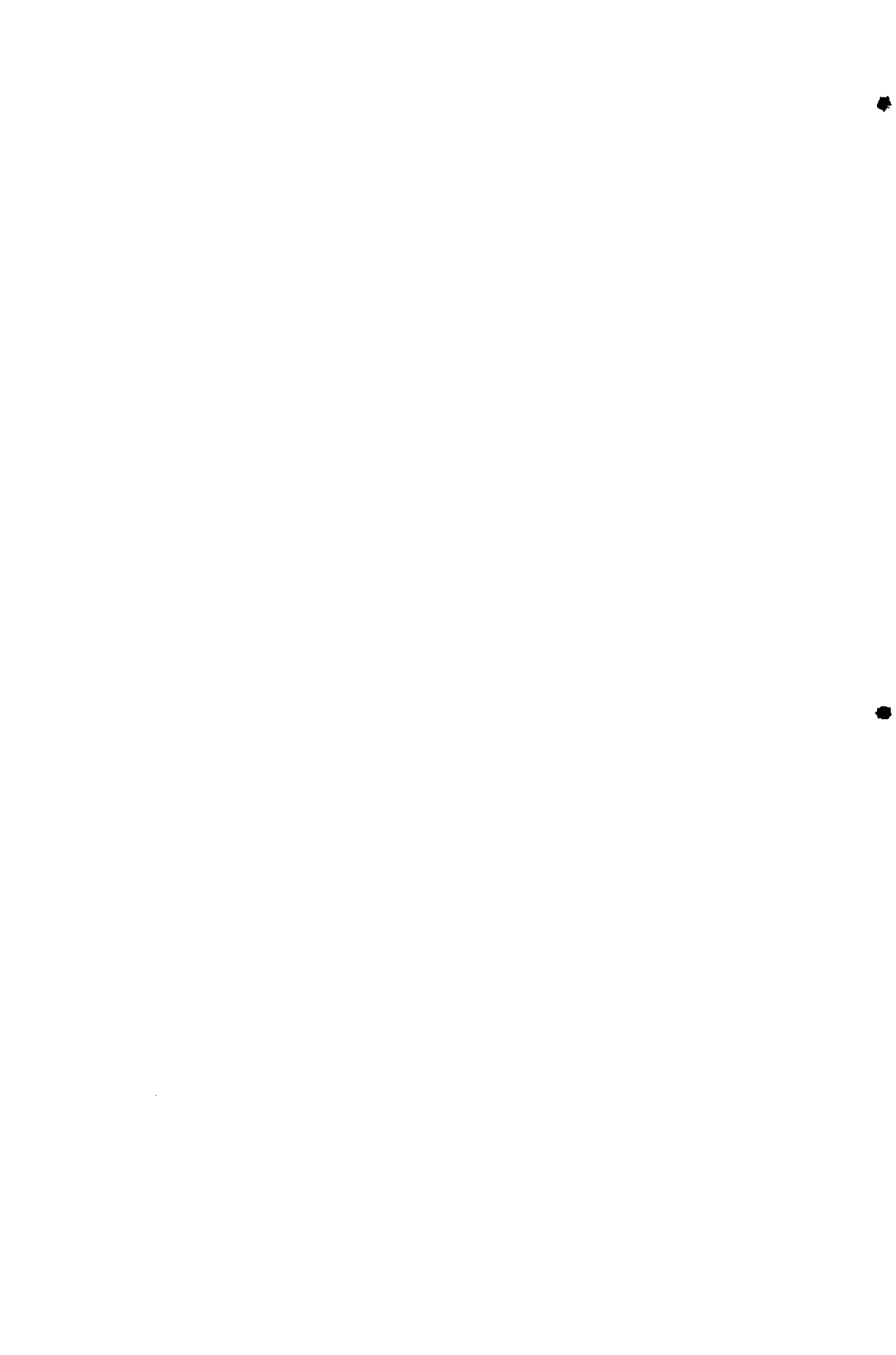

ON THE OPENING, ALLOCATION AND MANAGEMENT OF THE COMMUNITY
TARIFF QUOTA IN 1980 FOR FROZEN BEEF AND VEAL

Subject: Report on the opening, allocation and management of the Community tariff quota in 1980 for frozen beef and veal.

Article 6 of Council Regulation (EEC) No 2956/79 of 20 December 1979 opening, allocating and providing for the administration of a Community tariff quota for frozen beef and veal falling within subheading 02.01 A II b) of the Common Customs Tariff (1980)¹ provides that the Commission shall, not later than 1 October 1980, submit to the Council a report on the quantities for which licences have been issued in each Member State and that the Council, acting by a qualified majority on a proposal from the Commission, shall reallocate any unused quantities.

The information at present available to the Commission shows that;

- during the period 1 January to 31 July 1980 licences have been actually issued for a total of 31 039 tonnes, expressed in bone-in meat, namely 47.8% of the total quantities provided for; if the quantity allocated to Italy is not taken into account for this calculation, this latter figure becomes 62.0%.
- the actual granting of licences in 1980 as well as in 1979 and 1978, has been characterized by a substantial administrative delay in Italy;
- at the 400th meeting, of the Management Committee for Beef and Veal representatives of the Member States stated that the licences for the quantity outstanding would be issued between now and the end of the year.

For these reasons the Commission considers it unnecessary to make any re-allocation of the quota.
