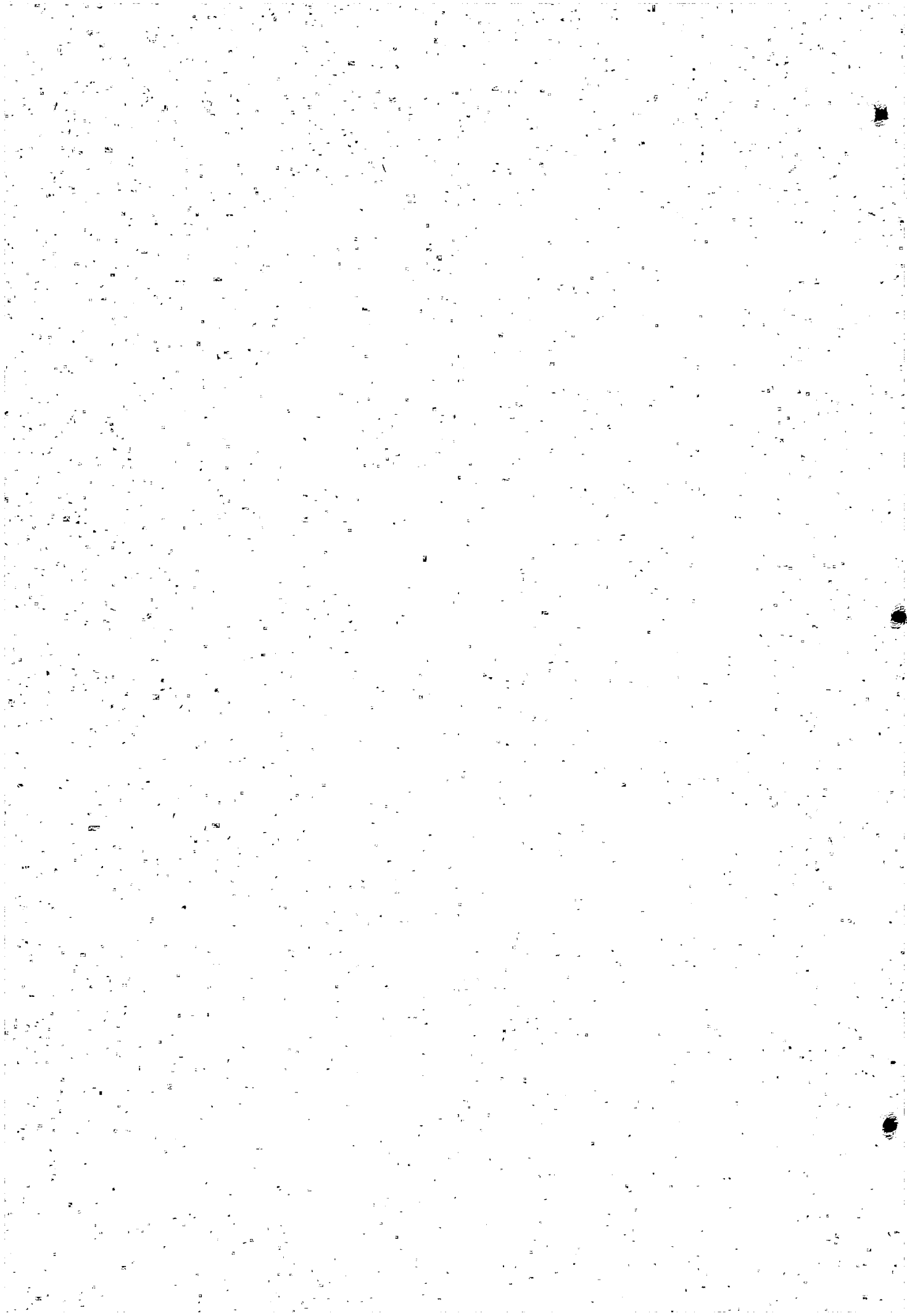

amending Regulation (EEC) No 1080/77 on the transfer to the Italian intervention agency of skimmed-milk powder

STATEMENT OF INTENT

Subsequent to its meeting of 18 - 22 April 1979, the Council has decided to adopt - as per the Commission's proposal - the following measures in the Milk and

Milk Products Sector:

- An increase in the Community contribution in favour of the relative Member States' programmes, for the transfer of milk products for schoolchildren at a reduced price, (an increase in the Community contribution provided for in Council Regulation (EEC) No 1080/77, of 100% % of the target price of milk at 1 September 1979), and
- the extension of the deadline fixed for the transfer to the Italian intervention agency of the quantity of skimmed milk powder mentioned in Council Regulation (EEC) No 1763/78.

It is therefore proposed that the Commission adopts the proposals contained in the attached Regulations, which consequently modify Council Regulations (EEC) No 1080/77 and 1763/78.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 804/68 of 27 June 1968 on the common organization of the market in milk and milk products¹, as last amended by Regulation (EEC) No 1761/78², and in particular the second paragraph of Article 26 thereof,

Having regard to the proposal from the Commission,

Whereas Council Regulation (EEC) No 1080/77³, as amended by Regulation (EEC) No 1039/78⁴, provides for a Community contribution to the cost of Member States' programmes for the supply of milk and certain milk products at reduced prices to schoolchildren;

Whereas, in order to encourage the consumption of more milk and milk products in schools, it is advisable to bring about a further reduction in prices by increasing the said Community contribution without increasing the actual amount of the mandatory financial contribution by the public authorities of the Member States,

HAS ADOPTED THIS REGULATION :

Article 1

With effect from 1 September 1979 Regulation (EEC) No 1080/77 is amended as follows :

1. In Article 1 (2) the amount "13 u.a./100 kg" is replaced by "21.40 ECU/100 kg".
2. In Article 2 (5) the expression "33%" is replaced by "25%".

Article 2

This Regulation shall enter into force on the third day following its publication in the Official Journal of the European Communities.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

The Council of the European Communities,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 804/68 of 27 June 1968 on
the common organization of the market in milk and milk products¹, as last amended
by Regulation (EEC) No 1761/78², and in particular Article 7 (4) thereof,

Having regard to the proposal from the Commission,

Whereas Council Regulation (EEC) No 1763/78³ provides for 100 000 tonnes
of skimmed-milk powder held by the intervention agencies of other Member States
to be made available to the Italian intervention agency, before 1 January 1980;

Whereas the Italian intervention agency is unable to take over the total amount
within the period specified; whereas that period must therefore be extended,

HAS ADOPTED THIS REGULATION:

Article 1

In Article 1 (2) of Regulation (EEC) No 1763/78, "1 January 1980" is amended to
read "1 November 1980".

Article 2

This Regulation shall enter into force on the third day following its publication in
the Official Journal of the European Communities.

This Regulation shall be binding in its entirety and directly applicable in all
Member States.
