THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Coal and Steel Community, and in particular the first subparagraph of Article 78b(2) thereof,

Having regard to the Treaty establishing the European Economic Community, and in particular the second paragraph of Article 204 thereof,

Having regard to the Treaty establishing the European Atomic Energy Community, and in particular the second paragraph of Article 178 thereof,

Having regard to the Financial Regulation of 21 December 1977 applicable to the general budget of the European Communities <sup>(1)</sup>, and in particular Article 8 thereof,

Having regard to the request from the Commission,

Whereas by its Resolution of 13 December 1979 the European Parliament rejected the draft general budget of the European Communities for 1980;

Whereas it is necessary to authorize several provisional twelfths in respect of certain budget headings for the European Parliament, with a view to meeting certain administrative requirements;

Whereas it is necessary to authorize such expenditure in excess of the twelfth;

Whereas since it is a matter of expenditure other than that necessarily resulting from the Treaty or from acts adopted in accordance therewith, it is necessary, pursuant to the second subparagraph of Article 78b(2) of the ECSC Treaty, the third paragraph of Article 204 of the EEC Treaty and the third paragraph of Article 178 of the EAEC Treaty, to forward this Decision immediately to the European Parliament;

Whereas, in the context of this Decision, it does not appear to be necessary to provide for measures in respect of resources,

HAS DECIDED AS FOLLOWS:

Article 1

The provisional twelfths recorded in the Annex are hereby authorized.

Article 2

This Decision is suspended in accordance with the second paragraph of Article 78b(2) of the ECSC Treaty, the third paragraph of Article 204 of the EEC Treaty and the third paragraph of Article 178 of the EAEC Treaty.
