Whereas, in its Resolution of 13 December 1979, the European Parliament rejected the draft general budget of the European Communities for 1980;

Whereas, in order to ensure the continuous operation of the EAGGF Guarantee Section, expenditure in excess of the twelfth should be authorized in respect of certain Chapters;
