concerning a multiannual programme for the promotion of renewable energy sources in the Community - ALTENER II

(presented by the Commission pursuant to Article 189 a (2) of the EC-Treaty)

EXPLANATORY MEMORANDUM

On 12 March 1997 the Commission adopted a proposal for a Council Decision concerning a multiannual programme for the promotion of renewable energy sources in the Community (Altener II). The proposal is based on Article 130(s) of the Treaty which provides for the cooperation procedure with the European Parliament. On 6 November 1997 the Parliament gave its opinion on the first reading. 24 amendments were voted and accepted.

The principal preoccupations of the Parliament matched those of the Commission. Of the 24 amendments proposed, the Commission accepted seven in their entirety and ten with re-wording.

Seven amendments have not been accepted, and one only partially (amendment $n^{\circ}20$), by the Commission for the following reasons:

- amendment nº 1

It is inappropriate to refer to a publication of conference proceedings in a legal text.

- amendment n° 3 idem

- amendment nº 4

The question of taking account of indirect costs in tariff calculation falls within the scope not of this programme but rather of the proposals on a Community strategy for Renewables which the Commission will be presenting separately to Parliament and Council.

- amendment n° 14

The amount of financing will be decided in accordance with the normal budgetary procedure, during which the budgetary authorities take all relevant aspects into account, including questions concerning Renewables as well as greenhouse gases.

- amendment n° 20

The concepts included in indents 3, 4, and 5 are implicit in the first and third as originally drafted.

- amendment n° 24

Reporting procedure is already stipulated in art. 6.

- amendment n° 26

The Comitology rules are laid down formally and this text should not provide otherwise.

- amendment n° 27 idem

The Council is requested to adopt its common position on the basis of the attached amended proposal.

HAS ADOPTED THIS DECISION:

Article 1

A five-year programme of measures 1 and actions to promote renewable energy sources in the Community, called ALTENER II, hereinafter referred to as 'the programme' is hereby established

Article 1

A five-year programme of measures and actions to promote renewable energy sources in the Community, called ALTENER II, hereinafter referred to as 'the programme' is hereby established

- (a) help create the necessary conditions for the implementation of a Community action plan for renewable energy sources, and in particular the legal, socioeconomic and administrative conditions, and to
- (b) encourage private and public investments in the production and use of energy from renewable sources.

The objectives contribute to achieving the overall Community objectives and concerns of limiting CO_2 emissions, increasing the share of renewable energy sources in the energy balance in accordance with the Community ensuring the security of energy supply, and fostering economic development, economic and social cohesion and regional and local development.

These include the development of sectoral and market strategies, the development of norms and standards, grouped procurement, comparative studies of the environmental impact and long-term costs and benefits, and the analysis of the legal. socio-economic and administrative conditions which are more favourable to the market penetration of renewable energies and the preparation of appropriate legislation;

pilot actions aimed at creating or extending infrastructures and instruments for the development of renewable energy sources in:

- local and regional planning,

- the tools for planning, design and evaluation,

- new financial and market instruments,
