

## The European Community in diagrams



Six Member States in 1952, twelve since 1986: the European Community today joins together 322 million people, from Denmark to Portugal, from the Shetland Islands to Crete. Although rich in their diversity, the Community countries also share a certain number of common values. By entering into partnership with each other, they want to increase the chances for democracy, for peace and for a more evenly distributed prosperity.

The Community countries intend to respond to the major economic challenges of our day, to improve their international competitiveness and thus increase employment, by abolishing between now and 1992 the remaining barriers to trade among themselves, and establishing a true Europe without frontiers. In so doing, they will build up the foundations for a European Union serving the interests of its citizens.






# The Community: moderate climate, restricted area

Average temperatures and hours of sunshine




# A dense population, but in relative decline

Density (inhabitants per sq. km, 1985)





## Total population, as % of the world population





Population by age groups (as %, 1985)




# Life expectancy at birth (in years, 1984)

Number of deaths at less than one year per 1 000 live births



Gross domestic product per head\* (World = 100, 1984)



(in purchasing power standards,\* 1985)





Household consumption, per head\*






As % of total household consumption,\* 1984













Orientation of third-level students (as % of the total, 1982-83)




Working population (%)





Proportion of women in the total of unemployed persons (as %, 1986)





# Inflation: clearly in decline

Consumer price index: rate of annual variation (as %)




# International trade: Europe in the lead


Receipts and expenditure for international tourism (x 1 000 million ECU, 1986)


Degree of energy dependency (as %)\*



\* share of net imports (imports minus exports) in total consumption.



## Employment sectors: the growth in services


Trend of industrial production (1980 = 100)


Degree of self-sufficiency (as %)\*





Community expenditure compared with overall public expenditure (as %)




Distribution of Community expenditure (as %, 1986)

European Parliament: composition by political group\*




## Number of seats per country




## Citizens of Europe: a democratic choice
