CONCLUSION OF THREE RENEGOTIATION AGREEMENTS WITH THE UNITED
STATES UNDER ARTICLE XXVIII(1) OF THE GENERAL AGREEMENT
ON TARIFFS AND TRADE

(Commission Communication to the Council)

The Commission hereby presents to the Council:

1. A report on the outcome of the negotiations it conducted with the USA under Article XXVIII(1) of the General Agreement on Tariffs and Trade regarding the withdrawal of concessions on a wide range of tariff headings in which the Community has an interest.

Annex II contains a list of the compensatory adjustments conceded by the USA in the renegotiations.

2. A report on the outcome of the negotiations conducted with the USA under Article XXVIII(1) of the General Agreement regarding the withdrawal of concessions on ceramic dinnerware in which the Community has an interest (Annex III). Annex V contains a list of the US withdrawals and compensatory adjustments under this head. Annex V contains copies of letters from the USA to the Community detailing the base rates of the US offer and the product cover of one of the US tariff lines.

3. A report on the outcome of the renegotiations with the USA under GATT Article XXVIII(1) regarding the withdrawal of concessions on

fabrics containing wool in which the Community has an interest (Annex VI). Annex VII contains a list of the US withdrawals and compensatory adjustments for these products under Article XXVIII.

The Article 113 Committee has approved the results of the negotiations referred to above.

The Commission recommends that the Council conclude the agreements negotiated with the USA under Article XXVIII (1).

Accordingly, it hereby presents the draft decision set out in Annex VIII.

Report on the negotiations

1. By communications dated 5, 12 and 21 October 1978 (GATT/Secret/249, 250 and 251), the US Government notified the Contracting Parties of its intention to modify undertakings entered into by virtue of the General Agreement, using the Article XXVIII(1) procedure; the notification concerned a large number of tariff headings. The aim of the negotiations requested by the USA was to convert a number of specific or mixed duties into ad valorem duties.
2. The Community claimed negotiating rights in respect of all tariff headings in which it had an interest as direct beneficiary, principal supplier or substantial supplier within the meaning of Article XXVIII.
3. In order to establish the converted rates and assess injury, the US Government proposed a three-year reference period covering 1975, 1976 and 1977. On the basis of precedent, the Commission pointed out that the reference period should take account of the most recent statistics available, i.e. those for 1978. Although the USA has never formally endorsed the Community argument, in nearly every case the compensation offered was based on a reference period covering 1976, 1977 and 1978.
4. In the majority of cases, converting specific or mixed duties into ad valorem duties would have resulted in increased duties from 1 January 1980, basing the calculations on the most recent reference period, since on the whole the prices of Community products over that period were higher than the average US import prices. For this reason the Commission negotiators were able to win approval for the argument that the incidence of specific duties should not be assessed in aggregate on total imports, but bilaterally, on imports from the Community alone, to reflect structural and price differences between the Community and its other trading partners.

5. With regard to compensatory adjustments, the Commission negotiators thus argued that the rates converted as of 1 January 1980 should not exceed the bilateral Community ad valorem mean. This prompted a request by the Community for a cut in the base rates and a faster tariff cuts schedule after 1 January 1980. The USA agreed to the request, even for a number of cases where it had made partial exceptions in its MTNs offer, but with the exception of ball bearings. At a meeting on 4 May 1979, the Article 113 Committee found that the compensatory adjustments offered constituted a satisfactory basis on which to reach agreement with the USA.

6. With regard to ball bearings, the USA maintained throughout the negotiations that no compensation was owing to the Community since the conversion would eliminate not only specific duties, but also the final list system, a method of customs valuation used in the USA which had the effect of increasing duties on bearings from the Community. According to the USA, the bilateral ad valorem average on the basis of these two elements was higher than the conversion rate it had proposed. The Commission negotiators rejected this argument, pointing out that the abolition of the final list system had already been dealt with in the separate, balanced set of negotiations on the customs valuation code. In the end the USA agreed to a Commission request for a half-point tariff cut on TSUS headings 664.05.50 (backhold shovels) and 664.05.35 (front loaders), plus a reduction from 4.2% to 2.4% on heading 668.20.35 (offset printing presses).

7. With regard to beer, the USA proposed that the specific duty should not be converted into an ad valorem duty provided the Community would agree to permit beer in 0.35 l containers to circulate in intra-Community trade. The Article 113 Committee, the Working Party on Economic Questions and the Permanent Representatives Committee, at its meeting

on 15 June 1979, examined the proposal. The Committee's advice was to accept the 0.35 l beer containers on a transitional basis until 1988.

8. The renegotiation agreement which forms Annex II was initialled on 26 June 1979.

The Commission accordingly proposes that the negotiations with the USA be concluded.

ARTICLE XXVIII:1 NEGOTIATIONS

Schedule XX - United States

The United States mission has transmitted to the secretariat on 17 July 1979 the attached report¹ concerning the results of negotiations between the United States and the European Communities on the conversion of specific to ad valorem duties in Schedule XX.

There shall be withdrawn from Schedule XX all existing concessions on the items listed in Annex I initially negotiated with the European Economic Communities or in which the European Economic Communities has a principal supplying interest. The new concessions granted shall be those granted by the United States on all the items listed in Schedule XX annexed to the Geneva (1979) Protocol. Implementation of these conversions and concessions shall be at the stages and under the conditions specified in Schedule XX. Schedule XX annexed to the Geneva (1979) Protocol will reflect concessions no less favourable than those shown in the Annex.

The United States has granted the concessions listed in Annex II to the European Economic Communities in Schedule XX to the Geneva (1979) Protocol, subject to the conditions thereof.

Report on the negotiations

1. By a communication (GATT/Secret/250) dated 12 October 1978, the USA indicated its desire to open negotiations with a view to withdrawing all their tariff concessions on ceramic dinnerware (TSUS headings 533.11 to 533.77) under Article XXVIII(1) of the General Agreement on Tariffs and Trade.

2. The withdrawal of the US concessions on dinnerware took place while the Multilateral Trade Negotiations were still going on. The offer of compensatory adjustments submitted at the end of October 1978 reflected a certain amount of restructuring of the US tariff in this sector, and included both higher duties on certain products, in particular dinnerware for hotels, and concessions within the framework of the trade negotiations.

In this sector the USA has also converted mixed duties on about twenty of the products involved de facto by expressing its offer entirely in terms of ad valorem duties.

3. In October 1978 the USA, pursuant to its Trade Act, and taking into account its desire to submit an offer for the whole sector, had not yet offered any concessions on these products, some of which had been subject to safeguard measures which were repealed by the President only in the course of that same month. However, while the offer on ceramic dinnerware was being prepared there had been contacts with the US Administration to make known the Community view on these products.

4. For that reason, the Community's requests in these negotiations concerned only a limited number of points:

- (i) request for an improved offer on hotel dinnerware (53320 and 53352); the 35% offer meant higher duties;
- (ii) inclusion of baby porringer and tea pots under "soups, oatmeals and cereals" and "beverage servers" respectively (533.37);
- (iii) request for an offer on salt and pepper shaker sets, oil and vinegar sets and egg cups (inclusion in 533.76 at 9% instead of 26% of earthenware or china other than bone china;
- (iv) request for the creation of a subheading plus an offer for products the same as those falling within 533.76 (candy boxes, bonbon dishes, etc.) but of pottery.

5. The USA accepted all the requests¹ except that for hotel dinnerware, of which the Community exports very little. The Article 113 Committee was kept up to date with the progress of the negotiations, and came to the conclusion that overall the US offer, modified as indicated, was an acceptable basis for settlement.

6. The renegotiation agreement (GATT/Secret/250/Add. 2 of 30 July 1979) was initialled on 12 July 1979. The Commission accordingly proposes that the renegotiations with the US Government be concluded.

I wish to confirm that "baby porringers: of fine grained earthenware or of fine grained stoneware (except articles provided for in new item 533.15) would be classified within new TSUS 533.37 as "...soups, oatmeals and cereals..." if valued over \$6 per dozen.

Similarly, "teapots" of the same materials (except articles provided for in new item 533.15) would be classified within new TSUS 533.37 as "...beverage servers..." if valued over \$42 per dozen.

Report on the negotiations

1. By a communication dated 5 October 1978 (GATT/Secret/117) the US Government notified the Contracting Parties of its intention to modify undertakings entered into by virtue of the General Agreement, using the procedure set out in Article XXVIII(1); the undertakings concerned wool blend textiles. The aim was to regularize US legislation dating from 1968.
2. With effect from 24 December 1968, the USA added a note (7) to Schedule 3 of the TSUS (fibres and textile products), stating that fabrics listed in parts 3 and 4 of the Schedule (woven fabrics and fabrics of special construction or for special purposes) would be treated as wool textiles, having wool as the main component, even where the main component in value terms was some other textile fibre. The effect of note (7) was to make certain fabrics which had previously been regarded as being of cotton, silk, etc., subject to the duties applying to wool fabrics, which were generally higher. However, note (7) did not apply to silk fabrics containing over 17% of wool by weight, of the jacquard type, falling within TSUS heading 337.50.
3. By virtue of the same piece of legislation, a duty of 37.5 cents per lb was added to the 32% ad valorem duty for TSUS headings 355.70, 356.30 and 359.30.
4. Despite repeated Commission efforts since 1968, the USA had never gone back on this decision, or even agreed to offer any compensation. It was only during the Article XXVIII(1) negotiations (see Annex I) that it finally agreed to settle this long-standing dispute. Although the USA


refused to offer any further cuts on wool-blend textiles other than to those conceded under the MTNs, it was prepared to offer a further one-point reduction on silk-blend fabrics falling within TSUS headings 337.20 and 337.40. The Community called for a speeding-up of the tariff reductions for these two headings, and the USA in the end agreed that the final 5% rate would be applied from 1 January 1983. The Article 113 Committee found that these compensatory adjustments were a satisfactory basis on which to reach agreement with the USA. The compensatory concessions offered by the USA on fabrics containing wool are listed in Annex VII.



COUNCIL DECISION

concluding three agreements between the European Economic Community and the United States of America under Article XXVIII(1) of the General Agreement on Tariffs and Trade

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Article 113 thereof,

Having regard to the recommendation from the Commission,

Whereas, by virtue of Article XXVIII(1) of the General Agreement on Tariffs and Trade, the United States Government has indicated its intention to withdraw concessions in which the European Economic Community has an interest; whereas negotiations have taken place on compensation for those withdrawals;

Whereas the Commission has conducted negotiations with the United States of America under the said Article XXVIII; whereas it has reached three agreements with this country and whereas these agreements have been found satisfactory,

HAS DECIDED AS FOLLOWS:

Article 1

The Agreements between the European Economic Community and the United States of America negotiated under Article XXVIII(1) of the General Agreement on Tariffs and Trade are hereby approved on behalf of the Community. The texts of these Agreements are annexed to this Decision.

Article 2

The President of the Council is hereby authorized to designate the person empowered to take the necessary measures to give effect to the obligations

undertaken by the Community.

Article 3

The Contracting Parties to the General Agreement on Tariffs and Trade shall be notified of the conclusion of the said Agreements.

ARTICLE XXVIII:1 NEGOTIATIONS

Schedule XX - United States

The United States mission has transmitted to the secretariat on 17 July 1979 the attached report concerning the results of negotiations between the United States and the European Communities on the conversion of specific to ad valorem duties in Schedule XX.

There shall be withdrawn from Schedule XX all existing concessions on the items listed in Annex I initially negotiated with the European Economic Communities or in which the European Economic Communities has a principal supplying interest. The new concessions granted shall be those granted by the United States on all the items listed in Schedule XX annexed to the Geneva (1979) Protocol. Implementation of these conversions and concessions shall be at the stages and under the conditions specified in Schedule XX. Schedule XX annexed to the Geneva (1979) Protocol will reflect concessions no less favourable than those shown in the Annex.

The United States has granted the concessions listed in Annex II to the European Economic Communities in Schedule XX to the Geneva (1979) Protocol, subject to the conditions thereof.




