CONSUMERS

The Council adopted, in the official languages of the Communities, the Resolution on the preliminary programme for a consumer protection and information policy.

- 4 --

Aware of the need for the Community to conduct a policy which consolidates and reinforces the various activities in this field, the Council affirmed its commitment to improving the quality of life for European consumers. The various experiments in progress in the countries of the enlarged Community are conducive to the rise of new ideas in this field which, combined with the ortion beig taken by the Member States as a whole, make it possible to view the status of consumers and the quest for a better balance in the defence of their interests differently than in the past.

The main aims of the programme are:

- effective protection against risks to the health or safety of consumers
- effective protection against threats to the economic interests of consumers
- compensation for damages and appropriate aid and advice in obtaining them
- educating consumers and keeping them informed
- consultation and representation of consumers when decisions affecting them are in preparation.

Lists of priority action will assist in the attainment of these objectives.

The fields which are of particular importance for consumer health protection and safety are as follows: food, cosmetics and detergents, tools and consumer durables, automobiles, textiles, toys, dangerous substances, objects which come into contact with food products, medicinal preparations, fertilizers and posticides, and veterinary products for animal feeding uses.

The programme further provides for the harmonization of the general conditions governing commune eredit, including hire-purchase, consumer protection against untruthful or misleading advertising and against certain abusive trade practices. The information required by the Commission to put forward proposals towards this end will be supplemented by studies.

As for assistance and compensation, the programme also provides for a series of studies, with particular reference / to systems of aid and advice in the Member States and also on systems for making complaints, arbitration and out-of-court settlement on disputes.

Priority forms of action concerning consumer information comprise more widespread publicity on the relevant general principles and rules, as for example on labelling, and comparative tests and studies on consumer behaviour. As for consumer training, provision is made for additional studies by the Commission in conjunction with the Member States

and consumer organizations to promote consumer education at school, university and other educational establishments and by furthering teacher training and the dissemination of information on a wider scale.

This latter aim will be pursued by means of a comparative study of the various types of consumer consultation, representation and participation employed in the Member States, by improved co-ordination of work carried out by national consumer organizations and by reminding Member States that consumer representatives may be appointed to the Economic and Social Committee.

When implementing this programme the Commission will take account of the studies and work already undertaken by the Member States, international bodies and consumer organizations, with which it will engage in collaboration with the latter in order to enable the Community to take advantage of work which has already been carried out.

This progamme is to be considered as the first stage of a more extensive programme which may well need to be developed in the course of time. The aim is to include this first phase within four years.

RAW MATERIALS

The Council conducted a general debate on raw materials in the context of relations with developing countries, thereby following the instructions given to the Council by Heads of Government at the European Council held in Dublin.

In the course of this discussion the Council noted that

- it was a matter of urgency that a common policy be framed covering all the various aspects of raw materials and in particular relations with developing countries
- the Member States should engage in close co-ordination at Community level as regards their positions within the various international bodies dealing with raw materials.

Consequently, the Council directed the Permanent Representatives Committee to continue its discussions on the basis of the guidelines evolved in the course of the meeting with a view to elaborating a joint policy on the matter, which would take account of the timetable of the various international meetings now scheduled.

EEC-GREECE ASSOCIATION

The Council signified its agreement to the texts of the Additional Protocol to the EEC-Greece Association Agreement and the Interim Agreement to be concluded consequent on the accession of new Member States to the Community.

These texts will enable the association between the Community and Greece to be applied to the three new Member States of the Community in accordance with the agreed provisions. The Interim Agreement is aimed at the advance implementation of certain provisions under the Additional Protocol relating to trade.

In addition, the Council agreed to propose to the Greek delegation that these texts be signed at a meeting of the EEC-Greece Association Council to be held at Ambassador level in Brussels on 28 April.

FISH FATS AND OILS

Following a brief discussion, the Council agreed to direct the Permanent Representatives Committee to resume its examination with a view to finding a solution to the matter as quickly as possible.

OVERALL MEDITERRANEAN APPROACH

The Council held a full exchange of views on the progress made in the negotiations with the various countries of the Mediterranean basin.

The Council approved the substance of the outcome of the negotiations with Israel and consequently agreed to take the necessary steps for the entry into force of the Agreement between the EEC and Israel on 1 July.

The Council also agreed to speed up the internal proceedings still to be completed concerning the overall Mediterranean approach, so that the Commission may bring the negotiations with the Maghreb countries to a close with all possible speed.

Lastly, the Council instructed the Permanent Representatives Committee to begin work on the development of the overall approach.

EMERGENCY AID TO VIETNAM

The Council signified its agreement to the Commission proposals for the grant of immediate aid to victims of the recent events in Vietnam. This emergency humanitarian aid totals 590 metric tons of skimmed-milk powder together with 300,000 UA for the purchase and transport of back-up food aid and medical supplies (through UNICEF), as well as 1,000 metric tons of cereals and 100 metric tons of skimmedmilk powder as part of an agreement with the Red Cross.

FOOD AID

The Council adopted the following Decisions on the Food Aid Convention:

- Decision concluding the Agreement between the European Economic Community and the Turkish Republic on the supply of common wheat as food aid (5,000 metric tons of common wheat under the 1973/74 implementation plan).


New procedure for the mana ement of food aid

The Council approved a simplified procedure for aid management by the Commission in order to accelerate the implementation of its own food aid decisions. Such food aid will still be managed on the basis of Council Decisions, but formal agreements will not be concluded in each individual case.

This procedure will apply to all forms of food aid granted by the Council as from the date of implementation of the 1974/75 cereals aid programme.

FISHERIES SECTOR

The Council heard a statement by the United Kingdom delegation emphasizing that in the very near future Community measures would have to be put in hand in the fisheries sector to counteract certain difficulties obtaining on the market and that the problems arising from the discussions conducted by the Conference on the Law of the Sea should be examined.

By way of conclusion to the discussions, during which a number of delegations indicated that they concurred with the viewpoint expressed by the United Kingdom delegation, the Council agreed to resume at its next meeting its examination of the problems currently affecting the market situation on the basis of proposals which the Commission undertook to submit to it in the very near future, and to carry out a joint examination of the outcome of the Conference.

OVERALL APPROACH TO THE MEDITERRANEAN COUNTRIES

The Council agreed to direct the Special Committee on Agriculture to examine the agricultural aspects of the ongoing discussions in the context of the overall approach to the Mediterranean countries in order to enable it to take the necessary decisions at its next meeting.

WINE

The Council conducted a detailed discussion of the short-term economic and structural problems affecting the wine sector.

At the close of the discussions it adopted the Regulation laying down general rules governing the distillation of table wines during the period from 7 June to 31 July 1975. The intervention price for these operations is fixed at 1.56 UA per degree per hectolitre.

In order to meet the special situation of certain distilleries in the Community, the date of application of the Regulation may vary in certain countries provided that the distillation period does not exceed 55 days.

In order to counteract the temporary overloading of the French market, aid may be granted for the stocking of Italian table wines imported into France on the basis of earlier contracts with French buyers.

In addition, the Council adopted the following Resolution concerning the new guidelines designed to balance the market in this sector:

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Whereas the present serious surplus on the table wine market proves the need for new guidelines in order to curb the development of wine production and restore the balance of the market in both the long and the short term;

Agrees with the Commission on the need to adopt measures within the context of Article 17(5) of Regulation (EEC) No 816/70 as regards regulations concerning planting and replanting to prevent the formation of structural surpluses while promoting a policy of quality,

Undertakes to adopt these measures by 1 August 1975; the Commission will submit appropriate proposals to the Council in good time,

Agrees to examine as having priority all the various amendments to be made to the basic Regulations in the wine sector, on the basis of the proposals already made by the Council and in the light of its discussions on 15 April 1975 and to take a decision by 1 August.

On the basis of this measure the Commission will be able, by dint of the "Management Committee" procedure, to fix a derived guide price for imports of frozen hake fillets from third countries.

Finally, with an eye to alleviating the difficulties obtaining in the fisheries sector, the Council, pending the Opinion of the European Parliament delivered pursuant to a Commission proposal, indicated that it was favourably disposed to the temporary institution of aid for private storage of the fisheries products listed in Annexes IIIA and IVB to the basic Regulation (frozen products), on the understanding that the Commission would submit a survey on storage measures by 1 November. The Commission did not exclude the possibility of its having to undertake certain measures at Management Committee level within three months, should storing still prove necessary.

CULTIVATION UNDER GLASS

In an introductory statement, the Commission representative submitted to the Council the proposal for a Regulation laying down certain measures for the rationalization of horticulture under glass.

The purpose of this proposal is to institute a premium for demolition which would be granted on condition that producers opting for the premium undertake not to extend their surface under glass for the next six years. Aids likely to increase the surface under glass would be prohibited during the time of the project (until the end of 1975).

The Special Committee on Agriculture was instructed to brief the Council on this subject.

COMPENSATION FOR THE RISE IN THE PRICE OF FUEL

The Commission representative also stated his Institution's intention to amend the communication of 12 June 1974 to Member States concerning national aid for the adaptation of the horticultural and fishery sectors to developments on the energy market. Pursuant to this amended communication, Member States will be authorized to continue until 30 June 1976 to grant degressive subsidies to compensate for the rise in energy prices which have occurred since September 1973.

In the fishery sector, the system for authorizing subsidies is extended for six months, i.e. until the end of the current year.

BEEF AND VEAL MARKET SITUATION

The Council discussed the current situation on the beef and veal market.

ENERGY AND PRIMARY PRODUCTS

The Council discussed the results of the preparatory meeting for the Conference proposed by the President of the French Republic, held in Paris from 7 to 15 April 1975. It was noted that the meeting had clarified the various points of view and that all those taking part had expressed a desire to continue the dialogue.

BEEF AND VEAL

The Council briefly discussed the situation in the beef and veal market.

In view of the fact that the situation of the market in adult bovine animals and calves in certain Member States, particularly Ireland, was causing concern, the Council requested the Commission to keep a close watch on market trends in this sector.

IMPORT OF TUNNY FISH

Following discussions on the decisions taken by the Commission to extend the safeguard measures applicable to the import of tunny fish intended for industrial processing, the Council took note of the Commission's intention to take the necessary decisions to extend beyond 1 July 1975 the temporary application of the safeguard clause to the market in France and to increase the amount of aid for private storage.

In this connection it noted that the Commission intended using this period of time to prepare a proposal to increase the reference price for tunny fish.

OVERALL APPROACH TO THE MEDITERRANEAN

The Council examined in depth the various problems in the agricultural sector posed by the negotiations with the countries of the Mediterranean.

The debate enabled the Council to appreciate more clearly the different aspects of the problems before it. Substantial progress was made concerning the guidelines along which solutions could be reached.

The debate brought to light a number of points requiring more detailed analysis. The Special Committee on Agriculture will continue its work in this respect on the basis of, in particular, further figures and suggestions which the Commission will present.

Conscious of the urgent need to reach concrete conclusions, the Council has agreed to proceed in the following manner:



Speech of Welcome by the President-in-office of the Council of Ministers, Mr. Richie Ryan T.D., Minister for Finance of Ireland on the occasion of the official visit of the President of Ireland on Monday, June 16, 1975.

Mr. President,

PRINCIPLE OF THE 40-HOUR WEEK AND 4 WEEKS'ANNUAL PAID HOLIDAY

The Council agreed to the Recommendation addressed to the Member States regarding the application before 31 December 1978 of the principle of the 40-hour week and 4 weeks' annual paid holiday.

The main aspects of the Recommendation are as follows:

- the normal working week should be a 40-hour week, apart from exceptions for certain specific sectors;
- the application of the principle may not entail a reduction in earnings;
- the minimum duration of annual paid holidays should be four weeks, and the paid public holidays falling within the period of annual paid holidays should be compensated in the form of an equivalent number of days to be added to the annual paid holidays;
- all provisions governing payment for holidays should be amended where necessary to take account of the application of the principle of 4 weeks' annual paid holiday, and the application of this principle should have no detrimental effect for workers in respect of holiday pay.

The Recommendation provides that the two principles shall be applied by 31 December 1978 at the latest, and if possible before that date. Member States are called upon to take appropriate measures to attain the objectives of the Recommendation in conformity with prevailing national practice and conditions, either by means of legislation, by encouraging employers and labour to conclude collective agreements or by any other means.

Member States shall inform the Commission of developments in the situation with regard to working hours and annual paid holidays to assist it in preparing its annual report on social developments in the Community.

FIGHT AGAINST POVERTY

The Council agreed in principle to the Decision concerning the programme of pilot schemes and studies to combat poverty.

- 6 -

The aim of this Decision, which was one of the priority measures in the Council Resolution of 21 January 1974, is to enable the Commission to promote or provide financial assistance for pilot schemes which:

- test and develop new methods of helping the poor and those threatened with poverty in the Community,
- are planned and carried out so far as possible with the participation of those concerned, and
- and of interest to the Community as a whole in that they deal with problems common to more than one Member State,

and also to promote, carry out or provide financial assistance for pilot studies which aim at improving understanding of the nature, causes, scope and mechanics of poverty in the Community.

Under the terms of this Decision, the Commission will be able to grant Community assistance normally amounting to 50% of the cost of the projects recommended. This percentage may be exceeded in the case of certain pilot studies.

The Commission will be assisted in its tasks by an advisory group composed of independent experts and representatives of the Governments of the Member States.

The Council discussions dealt mainly with the choice between the various possible approaches for ensuring that intervention by the Social Fund had genuine impact. In this connection, the criteria to be adopted to determine the sectors or categories and the fixing of any priorities were discussed in detail.

For this purpose the Council had before it the Commission proposal, the Opinion of the European Parliament and a report on the initial discussions in the Economic and Social Committee.

The Council also bore in mind the guidelines evolved on the matter by the Standing Committee on Employment at its last meeting on 3 June, which showed a clear preference for concentrating these measures on young workers in particular,



VETERINARY QUESTIONS

The Council adopted (¹) the Directive, amending the previous Directives on the procedures of the Standing Veterinary Committee, and the Decision amending the previous Decision with the same aim. The Directive and Decision in question are concerned with the extension, for a period of six years, of the existing procedures, including the retention of the right of appeal to the Council against the Committee's decisions (so-called "safety-net" procedure).

The Council also adopted in principle (²) the Directive amending the Directive on health problems affecting trade in fresh poultrymeat. Inter alia, the Directive extends until 31 December 1977 the derogation allowing the "Spinchiller" process to be applied. In the meantime the Commission will prepare a study on alternative industrial measures, to be submitted to the Council not later than 1 July 1976.

HORTICULTURE UNDER GLASS

The Council took note of an interim progress report by the Chairman of the Special Committee on Agriculture on work in connection with the proposal for a Regulation laying down measures for the rationalization of horticultural production under glass.

The various delegations commented on this matter and emphasized, for the most part, that the proposal should be viewed in a wider context taking account, in particular, of the questions of energy costs and national aids.

The Council instructed the Special Committee on Agriculture to examine this subject again in the light of the Council's discussions.

SUGAR SECTOR

The Council discussed the measures to be taken to supplement the provisions of the Regulation on the common organization of the markets in the sugar sector.

- 6 -

In this connection, the Council recorded its agreement in principle to a national structural aid to the production of sugar in the French overseas departments in view of the particular social, economic and climatic conditions obtaining in those departments. During the sugar marketing years 1975/76 to 1979/80, the French Republic is authorized to grant adaptation aid to sugar-cane producers and to the sugar-cane processing industry in the overseas departments. For both sectors together, such aid may not exceed 5 UA/100 kg of sugar, expressed as a value of white sugar. Aid may be granted only for a quantity of sugar not exceeding the basic quantity allocated to the French overseas departments.

At the end of the discussion, the Council agreed to instruct the Special Committee on Agriculture to re-examine the questions still outstanding in this sphere, so as to enable it to take the necessary decisions at its next meeting.

OLIVE OIL

The Council adopted a Regulation (¹) on the advance application of the threshold price for olive oil (146.96 UA/100 kg) for the 1975/76 marketing year on 27 June 1975 instead of on 1 November 1975, as originally planned.

This measure, together with the one already adopted by the Commission concerning the suspension of advance-fixing, proved necessary to stabilize the Community olive oil market with regard, firstly, to the level of stocks still held by producers and, secondly, to the number of recent applications for import licences, which far exceeded normal Community requirements, and also to the relationship existing between world and Community prices.

BEEF AND VEAL

In the context of its periodic review of the situation on the beef and veal market, the Council took note of a communication from the Irish delegation and a Commission communication regarding the latest market trends in this sector.

The Council noted that a certain number of new questions had arisen since the last meeting, namely

- the difficulty of maintaining arrangements as regards boning which complied with general Community standards;
- a request by one delegation to be allowed to sell quarters at reduced prices, so that it could free certain storage facilities before cattle were brought down from summer pasture;
- the advisability of temporarily suspending the purchase of cows by intervention bodies.

Finally, it agreed to request the Commission to keep an eye on market trends in this sector and to report back to the next agricultural Council.

WINE

(a) The Council took note of an interim report by the Chairman of the Special Committee on Agriculture regarding progress on the Regulations amending the basic wine regulations.

During a brief debate, the Commission stated that it would shortly be submitting additional proposals, some of which would constitute amendments to its initial proposals. The Council agreed that the European Parliament and the Economic and Social Committee should be consulted immediately on these texts.

In the interests of keeping to the deadline of 1 August adopted at an earlier meeting, the Council agreed to instruct the Special Committee on Agriculture to push ahead with all speed in this sector so that a decision might be taken at the next meeting on agricultural questions on 21 and 22 July 1975.

(b) Basing itself on a statement by the French delegation, the Council also held an exchange of views on the situation on the wine market, harvest forecasts and ways in which a wine slump could be avoided.

OVERALL MEDITERRANEAN APPROACH

The Council agreed in principle on certain measures for the organization of markets on which the agricultural concessions depend in the context of the overall Mediterranean approach. These measures concern in particular the processed fruit and vegetables sectors, citrus fruit and out of season fruit and vegetables, and wine.

Processed fruit and vegetables

The Council agreed to

- liberalize trade with third countries in products in this sector
- appl a system of minimum import prices for <u>tomato concentrates</u> and a system of import licences
- maintain until 31 December 1977 national measures on <u>citrus</u> <u>fruit juices</u> apart from grapefruit juices, the Council deciding before the end of that period on the arrangements to be introduced subsequently. If no decision is taken before the date mentioned, the previous arrangements will still apply;
- maintain until 31 December 1977 national arrangements for prunes

- exclude from the scope of the new system trade with third countries in processed potatoes with a view to including them in a common organization of the market for all potatoes, the Council having to adopt the Regulation concerned before 31 December 1975:

- extend to all quantities of oranges for processing

the processing premium provided for in Regulation No 2601/69: - introduce a system of import certificates as provided for in Regulation No 193/75. As regards <u>tinned pineapple</u>, the Council agreed to adopt the Regulation introducing a system of production aid for tinned pineapple, to be granted by the Member State on whose territory the tinned pineapple is produced. Production aid will be granted only to those processors who undertake to pay a minimum price to pineapple producers, the level of which will be established by the Council.

Finally, the Council noted that

- following the introduction of a system of trade with non-member countries, the Commission undertakes to keep the situation in the processed fruit and vegetables sector under surveillance, in particular as regards the influence of the cost of the basic product, and to take all the necessary measures to overcome any difficulties;

- if difficulties should arise in the fruit and vegetable processing industries following the introduction of this system, assistance from certain Community financial instruments (the Guidance section of the EAGGF, the European Regional Development Fund) could be envisaged, provided that the action proposed by the Member States falls within the scope of the regulations governing the said instruments.

Fresh fruit and vegetables

As regards oranges and small citrus fruits (mandarins, clementines etc.) the Council agreed to smend Regulation No 2511/09 (from the entry inco force of the Mediterranean agreements) as follows:

The Council also recommends strengthening the <u>system of reference</u> prices in this sector.

To this end, the Council agreed to amend Regulation No 1035/72 by including provisions affording the possibility of levying a compensatory tax on products in respect of which a reference price is fixed not only, as laid down under present arrangements, when entry prices for such products are below the reference price on two consecutive market days, but also when, for a certain period, entry prices are alternately above and below the reference price.

As regards lemons, the Council agreed to

- amend Regulation No 2511/69 (as from the entry into force of the Mediterranean agreement) by introducing, for the 1975/76 marketing year, a marketing premium for lemons of 4.7 UA/100 kg (1.2 UA for there not being a contractual price and 3.5 UA for transport costs not having been included in the reference prices);
- amend Article 23(2) of Regulation No 1035/72 to offset, for that part of the 1975/76 marketing year still to run after the entry into force of the Mediterranean agreements, the non-inclusion of transport costs in the reference prices for lemons;
- review the situation for subsequent marketing years in the light of the results of the study to be carried out by the Commission on the situation on the market in lemons in the Community and to take appropriate steps with a view to remedying any difficulties which might occur in respect of the disposal of that product either in its fresh state or after processing.

As regards <u>aubergines</u>, <u>avocadoes</u> and <u>fresh pineapple</u>, the Council noted that the Commission had undertaken to follow market trends for these products and that it would either 'take or propose to the Council appropriate measures should these products encounter marketing difficulties in the Community.

Wine

In the case of wine imported from the Maghreb countries, when a quantity submitted to customs does not observe the reference price,

- the customs authorities are obliged to apply the full duty to this quantity. This obligation will be included in a Council Regulation based on Article 43 which will also prescribe the necessary document together with the practical rules enabling the customs authorities to apply this measure by simply comparing figures.

In order to enable the customs authorities to operate in such a manner, the document in question should consist of a certificate similar to that used for Emmenthal cheeses certifying that the free at frontier price has been observed. Also, the concept of the free at frontier price should be defined in an implementing regulation adopted in accordance with the Management Committee procedure. Finall, the free at frontier price could be supervised in accordance with the same principles as those applied for the rules governing the value for customs purposes.

- the Management Committee shall examine cases where the full

Any measures decided upon will be reviewed monthly.

As regards imports from other non-member countries which have undertaken to comply with the reference price pursuant to Article 9(3) of Regulation No 816/70 and which are not eligible for tariff preferences, the present arrangements will be strengthened in the following ways:

- when a quantity submitted for customs clearance does not observe the reference price, the customs authorities shall immediately inform the Commission of the cases established (by telex).
- the Management Committee shall examine the cases established so that, if such cases are found to be significant, a Commission decision can be taken by the Management Committee procedure for the purpose of applying the compensatory tax laid down for each consignment imported from the country in question, in accordance with Article 9 of Regulation No 816/70.

Any measures decided on will be re-examined monthly.

New version of Article 33a concerning special distillation

Where the volume of existing stocks in the Community, plus the volume of imports of wine from Algeria, Morocco and Tunisia, causes disturbance on the Community market, a special distillation operation for table wines shall be carried out; it shall be confined to producers' organizations.

This distillation will be carried out at a price which will ensure that producers are compensated.

The Council, acting on a proposal from the Commission and in accordance with the voting procedure laid down in Article 43 (2) of the Treaty, shall adopt general rules for the application of this Articlé before 1 August 1975.

Implementing rules, and in particular the decision relating to the special distillation operation, shall be adopted in accordance with the procedure laid down in Article 7 of Regulation No 24.

In an interpretative statement, the Council agreed to recognize that Article 33a does not deregate from Article 14. Consequently, since each of these two operations (safeguard clause and special distillation) is designed to meet specific and particular conditions, recourse to one does not preclude recourse to the other.

The following <u>details of the special distillation operation</u> are to feature in the proposal for general rules to be adopted by the Council under Article 33a (2) of Regulation 816/70

ACP and OCT

Interim arrangements

The Council - or in certain cases the representatives of the Governments of the Member States - approved a whole series of measures designed to provide for the advance implementation on 1 July 1975 of the arrangements established by the ACP-EEC Convention of Lomé. These measures were:

- a Council Regulation on the advance implementation of certain provisions of the ACP-EEC Convention of Lomé relating to trade in goods
- a Council Regulation on the arrangements applicable to agricultural products and certain goods resulting from the processing of agricultural products, originating in the ACP States or the OCT
- a Decision by the representatives of the Governments of the Member States of the ECSC meeting in Council opening tariff preferences for products within the province of that Community originating in the ACP States and the OCT.

These measures were a result of the undertaking given by the Community on 28 February last in Lomé that it would implement certain provisions of the ACP-EEC Convention on trade in goods unilaterally as from 1 July.

In this context, the Council also approved the arrangements by which rum originating in the ACP States will be governed until 31 December 1975.

These arrangements provide for a Community quota to be admitted free of duty.

The Regulation on agricultural products and the Decision on products within the province of the ECSC likewise apply to products originating in the OCT.

The Council also adopted a Regulation on interim trade arrangements with the OCT subject to the formulation of a supplementary Regulation on rum originating in the OCT.

Exports of ACP beef and veal to the Community

Certain ACP States, particularly Botswana, had on several occasions drawn the Council's attention to the major difficulties they were encountering as a result of the critical situation of their exports of beef and veal towards the Community, these being traditional exports and the mainstay of their economy.

In response to these moves and requests from several Member States, the Council held a detailed examination of measures which could be introduced to assist these countries which have particularly low incomes without the principles governing the operation of the common organization of the market in beef and veal being jeopardized.

To this end, the Council agreed to adopt provisions whereby levies will be reduced by an amount corresponding to 90% of the average levies actually charged, although this measure will apply only where the exporter States concerned (Botswana, Swaziland, Kenya and Madagascar) have actually charged an export tax of an amount equal to the abovementioned reduction in the levy.

Internal agreements relating to the ACP-EEC Convention of Lomé

With a view to assuring implementation within the Community of the ACP-EEC Convention of Lomé, the representatives of the Governments of the Member States meeting in Council approved

- firstly, the internal agreement on the measures and procedures required for implementation of the ACP-EEC Convention of Lomé,
- secondly, the internal agreement on the financing and administration of Community aid.

These two instruments, which will be signed as soon as possible, will be submitted for ratification in the Member States and will enter into force on the same day as the Convention of Lomé.

REDUCTION OF OIL CONSUMPTION

In the context of the reduction of oil consumption, the Council adopted the Resolution on the setting of a short-term target for 1975 and received a further communication from the Commission on energy saving targets for 1976-1977.

To attain the main target for 1976, which was to hold consumption down to the 1973 level despite the growth in the economy, and to achieve the 1977 objective, the Commission recommended measures aimed at effectively reducing the part played by non-useful energy consumption, viz. wastage and low efficiency.

The Council once more emphasized how important it felt this problem to be and confirmed its wish to achieve concrete results by the autumn. The Council instructed the Permanent Representatives Committee to examine the draft Resolution which the Commission intended to submit on this subject.

REVIEW OF THE JRC MULTIANNUAL RESEARCH AND TRAINING PROGRAMME AND THE NEW ACTIVITIES FOR THE PETTEN ESTABLISHMENT

At the close of a detailed discussion, eight delegations agreed on new proposals relating to the review of the JRC multiannual research and training programme and to new activities for the Petten establishment.

MANAGEMENT AND STORAGE OF RADIOACTIVE WASTE

The Council adopted a five-year environmental programme concerning the management and storage of radioactive waste. The aim of the programme will be the joint development and perfecting of a system of management of radioactive waste produced by the nuclear industry which, at its various stages, affords man and his environment the best protection possible.

COMMON POLICY ON SCIENCE AND TECHNOLOGY

The Council took note of a statement by the Belgian State Secretary on the progress of the preparation of a common policy on science and technology.

The Belgian State Secretary emphasized in this connection that the Community was half way through the period laid down in the Council Resolutions of 14 January 1974 for preparing the implementation of a common policy in the sphere of science and technology.

These preparations included, inter alia, a comparison and examination of Member States' national policies and of the objectives aimed at by them, in order to work out common objectives.

The Belgian State Secretary said that this aspect of the work of preparation had lagged behind the programme of work appended to the Resolutions of 14 January 1974.

He stressed that the comparison of national research policies must be speeded up and given enough real impetus by focussing on certain sectors, in line with the wish expressed by the CREST Committee at its meeting on 10 January 1975.

He also stated his contern that the Community should avoid theoretical discussion and academic activity in the field of research. The target to be achieved promptly and one which would justify the preparatory activity referred to in the Resolutions of 14 January 1974 was the implementation of specific research projects.

The State Secretary also drew his colleagues' attention to the problems arising from the great number and, on occasions, from the insufficiently precise terms of reference, of the various working parties and committees responsible for the Community's scientific research.

In view of the importance and complexity of the matters likely is raised, the Belgjen State Secretary asked the Council, to fix a fresh date for a meeting to discuss the abovementioned points in detail. In his opinion, the next Council meeting on energy should also concern itself with preparations for the Joint Research Centre's new multiannual programme and adopt the multiannual programme on thermonuclear fusion.

ENERGY RESEARCH AND DEVELOPMENT PROGRAMME

Seven delegations agreed on the energy research and development programme proposed by the Commission, involving a maximum amount of 59 MUA, a staff of 27 and a period of four years from 1 Jul 1975.

The programme would be reviewed before the end of 1976 so as to allow the implementation of any amendments to the programme resulting from this review in early 1977 at the latest.

It would also be agreed to make available a first budgetary instalment of 12 MUA reserved for the first stage of the programme, from 1 Jul; 1975 to 31 December 1976, and to decide on the second budgetary instalment after the programme had been reviewed.

The German delegation reserved its position at this juncture: it will inform the Council, after its Government has made a fresh examination, whether it will be able to give its agreement. If not, the matter will be submitted to the Council afresh.

The Italian delegation also maintained its reservation on this matter at this stage of the proceedings.
