Amendment to the proposal for a

Communication to the Council

Explanatory Note

In April 1982¹, the Commission submitted a proposal for a Council Directive on the facilitation of formalities and inspections in respect of the carriage of goods between Member States. The European Parliament delivered its opinion on 13 January 1983². In the light of this opinion, the Commission has decided to amend its proposal, as permitted by Article 149 of the EEC Treaty.

Details of the amendments

Article 4

This addition expands on the provisions of the second paragraph of Article 4. The intention is that the Commission will use the information supplied by the Member States in order to compile a guide containing copies of the main national inspection certificates and translations in the other official languages. An adequate number of guides will be sent to the Member States so that each control post can have a copy.

Article 9

It is feared that the setting-up of mixed committees at national and local level might create excessively rigid and cumbersome structures. The procedure now proposed, whereby one Member State can consult another Member State on an optional basis with the Commission arbitrating, should make it possible to achieve the desired result.

Amendments to be made

Article 1: Unchanged

Article 2: Unchanged

Article 3: Unchanged

Article 4: Add a third alinéa worded as follows:

"The Commission shall provide each Member State with official translations of all such documents in the official language(s) of the Member State in question. Member States shall ensure that officials at inspection posts have at their disposal the authentic national inspection documents and translations thereof".

Article 5: Amend paragraph 2 to read as follows:

"Bilateral contacts between Member States shall be established or, where they already exist, shall be strengthened, in order to seek appropriate cooperation between the various inspection departments on either side of common frontiers between Member States".

Add an Article 6a, worded as follows:

"Member States shall ensure that any payments due at frontier crossing-points may be made with bank cheques such as Eurocheques or similar means of payment or in the currency of another Member State where no exchange facilities are available at the frontier crossing-point in question".

Amend Article 9 to read as follows:

"A Member State may consult another Member State in order to seek solutions to problems arising in respect of inspections or formalities within the meaning of this Directive. If the problems in question cannot be resolved by such consultations, a Member State may inform the Commission, and the latter shall make such recommendations as it considers necessary to resolve these problems".
