This annual report is intended to provide information on the action taken on Parliament's resolutions by the other Community institutions.

The follow-up process falls into three stages:

- (1) A brief analysis of the resolutions adopted at each part-session is produced immediately after the part-session concerned ('monthly summary').
  The Commission usually submits a reply on the first day of the following part-session.
- (2) A <u>quarterly report</u> is drawn up some months later, indicating the action taken at that stage by the other Community instututions.
- (3) A year later, the quarterly reports covering the annual session are amalgamated and updated. The present <u>annual report</u> thus covers the 1978/79 session. It has been drawn up in English and, in view of its bulk, it is not proposed to have it translated into the other official languages, unless the need for this should arise.

Quarterly reports covering the 1979/80 session are available in all languages as follows:
