**Presidency Progress Report on Better Regulation**  
**Presented by the Czech Presidency to the Competitiveness Council**

*Simple and clear rules for strong economy*

**Introduction**

1. The Presidency recalls that the Council has adopted conclusions on a number of occasions stressing the key role of the Better Regulation agenda as part of the Lisbon Strategy for growth and jobs. The importance of an effective regulatory framework for promoting competitiveness and growth with the internal market as a core pillar has also been underlined by the European Council.
2. The Presidency considers that clear, simple and consistent rules which facilitate the exploitation of the potential of the internal market for businesses, not least SMEs, and strengthen their competitiveness in world markets have become increasingly significant in the present economic downturn. Clear and simple rules at EU level providing for an effective and enforceable regulatory environment support the aim of the internal market – to boost cross border trade and to attract foreign investments and thus strengthen competitiveness and the position of the EU enterprises in a global context. It therefore welcomes the Commission's **Third Strategic Review of Better Regulation**<sup>1</sup> which the Presidency sees as a continued commitment to the better regulation principles for improving the quality and effectiveness of EU legislation and policies.
3. The aim of this report is both to take stock of recent progress in the area of Better Regulation and to set out the views of the Czech Presidency as to how the Better Regulation policies in the EU can be developed further.

## Impact Assessment

4. The challenges of the current economic crisis necessitate both short term action and longer term economic reforms by the EU and the Member States in a coordinated response. Relevant and well targeted regulation and policies should be based on quality evidence drawn from robust impact assessments. The Presidency considers impact assessment to be a continuous process and an integral part of the analysis and decision-making process. Each legislative proposal must be properly justified in relation to the subsidiarity and proportionality principles. A high standard of impact assessment with, to the extent possible, quantified costs and benefits of available options facilitates the decision-making process and final agreement on regulations.
5. The Presidency therefore welcomes the Commission's ongoing commitment to improve the impact assessment system. In 2008 this was underlined by the revision of the **Impact Assessment Guidelines**. The revised text provides for improved guidance, e.g. on subsidiarity, increased 'ownership' of impact assessments and timing of preparatory works within the Commission, quantification including of administrative costs, as well as efforts to improve quality and consistency of impact assessment studies.
6. The quality of impact assessment is dependent on the quality of evidence that is available. The Presidency stresses the importance of targeted and well prepared **consultations** so that stakeholders may respond effectively, whilst paying attention to proper timing of the whole legislative process. The Presidency welcomes the Commission's encouragement to its departments to go beyond the 8 week minimum consultation period for complex or sensitive proposals so that all stakeholders are aware and able to contribute to consultations. It underlines the necessity of clear feedback on the results of consultations in the final impact assessment, including on how the results have been used. It believes furthermore that additional options for continuous involvement of stakeholders in the further stages of the preparatory process on impact assessments should be considered. This would help to manage stakeholders' expectations for the final proposal and to test policy options under consideration and their likely costs and benefits.

7. The Presidency also notes that within the integrated approach to impact assessment the "SME test" will provide specific guidance so that the costs and benefits for SMEs are routinely scrutinized in the preparation of new initiatives, policies are proportional to the aims, easily understandable and facilitate market access especially for small and **microenterprises**. Furthermore, new proposals should be carefully evaluated with regard to their implications on the Four Freedoms of the internal market and their compliance with the non-discrimination principle. In addition, the **external dimension** of internal market policies should be properly assessed as part of the impacts on global competition. Finally, the new guidance on **impacts on national and regional level** should take into account specific impacts, where relevant, for certain Member States and regions.
8. In addition to the quality of impact assessment data, a clear presentation of the main findings and key figures is equally important so that they can be easily and effectively assessed. Recalling Council conclusions adopted on 29 May 2008<sup>2</sup> the Presidency stresses the importance of **short executive summaries**, for presentation of quantified key benefits and costs, including administrative costs for businesses, and considers that such summaries should normally cover all options, not just the chosen one. Thoroughly evaluated alternatives can speed up the decision-making process in the institutions in cases where the co-legislators would opt for different solutions than the originally proposed option.
9. The Presidency acknowledges the important role of the **Impact Assessment Board (IAB)** for promoting high quality impact assessment studies in the Commission. Accordingly the Presidency encourages the Council's preparatory bodies to refer to IAB opinions alongside impact assessments for proper evaluation of draft proposals and for assessing potential amendments. The increasing emphasis on the need to quantify impacts more systematically and to address administrative burdens is a particularly welcome development.

The Presidency invites the Commission to consider possibilities to make use of external expertise more regularly in its work on impact assessments. Furthermore, it is the Presidency's view that the impact assessments should include a comprehensive reasoning in cases where the IAB's recommendations have not been followed.

10. The Presidency also welcomes the launch by the three Institutions of the **review of the Common Approach to Impact Assessment** in July 2008 and looks forward to its conclusion as soon as possible, stressing the need for practical and workable solutions.

### **Administrative Burdens Reduction**

11. The Presidency welcomes the recently published results of the measurement which provide indicative information on the baseline of existing administrative burdens across the priority areas. Given the ambitious goal of the Action Programme and its timetable, the Presidency stresses that early submission of proposals for reduction measures is crucial if the target of a 25% reduction of administrative burden arising from EU legislation is to be achieved by 2012.
12. The Presidency therefore welcomes the announcement of the first package of reduction measures covering actions already taken or to be proposed which is to provide for a potential of 30 billion euros for businesses in estimated savings<sup>3</sup>. It fully supports the intention of the Commission to present all proposals for the 25% reduction target before the end of its mandate and appreciates the work of the High Level Group of Independent Stakeholders on administrative burdens in developing concrete recommendations for action. It regards with favour the announcement of the Commission to extend the action programme to include further 30 legislative acts, both adopted or to be proposed.<sup>4</sup>

13. During the current period of economic crisis, the credibility of the programme is dependent on reassuring businesses that the programme will deliver results: that it will reduce unnecessary existing burdens and contribute to the prevention of unnecessary new ones. The Presidency underlines that tangible reduction of administrative burdens can take place only if based on the existing stock as well as on legislation in preparation. It is the Presidency's view that the intensive work carried out in recent months on collecting data on existing administrative burdens in priority areas should be extended to include, in principle, all relevant policy areas. The Presidency considers that the announced Commission proposal on **sectoral reduction contributions** should reflect such an approach.
14. Similarly, the Presidency considers that it will be important early in the mandate of the next Commission to decide whether the Action programme on reduction of administrative burden is a "one-off" exercise or should be developed into an ongoing programme in which the effort on continuous reduction of administrative burdens would be merged within the new simplification programme.
15. Quantitative data, including an **evaluation of administrative burdens**, in impact assessments on new proposals remain crucial for a clear understanding of the potential costs for businesses. The Presidency therefore welcomes the Commission's intention to exploit IT tools for this evaluation and invites the Commission to ensure that quantifying administrative burdens in impact assessments becomes the rule in all relevant cases.
16. Furthermore, it notes that unnecessary administrative burdens will not only be suppressed by withdrawing information obligations, but also by improving how information is collected. In any case, it is important to carefully apply the "**only once**" principle in order to prevent the imposition of repeated obligations for information from businesses that is already available, while respecting Member States' internal administrative specificities in order to avoid disproportionate costs for administrations.

17. The Presidency welcomes the cooperation of the Commission and the Member States regarding the implementation of the **Services Directive**. This should ensure that the implementation is carried out correctly by avoiding goldplating practices, reducing administrative burdens and providing for simplification of administrative procedures.
  
18. The Presidency notes that, until now, 21 Member States have fixed their **national reduction targets** for administrative burdens stemming from national legislation in accordance with the Spring European Council's Conclusions of 2007 and invites the Member States to continue with their efforts to implement these plans. The Presidency acknowledges the Commission's effort to assist the Member States in their task through making available a starter kit for launching and measuring the actual administrative burdens.

### **Simplification**

19. The Presidency welcomes the achievements presented by the Commission in the **Third Progress report on the strategy for simplifying the regulatory environment**. It also welcomes the results of the **screening of acquis** with 81 new actions that the next Commission may consider for a future simplification programme. The Presidency underlines that the simplification programme should simplify in a concrete and tangible way the regulatory environment and support the reduction of burdens for businesses and citizens.
  
20. The Presidency is aware of the large number of **simplification proposals** (see table in Annex II) on which agreements are still pending in the Council and the European Parliament. The Presidency will pay special attention to these proposals.

21. The Presidency would like to underline the importance of using information provided by **ex post evaluations**, e.g. to assess the actual effect of approved EU legislation against its intended scope and impact. The Presidency therefore calls for the Commission's impact assessment studies to include core progress indicators for future monitoring and evaluation of adopted proposals and recalls the need to include a review clause in new legislation, where appropriate. Ex post evaluation data should be used to help guide and prioritise future simplification exercises.

### **Access to law and guidance on legislation**

22. In order to fulfil its intended aims and be effective in practice, legislation must be perceived properly and timely by European citizens and businesses. This means that it must be drafted in a simple and clear way and be accessible. Consequently, the Presidency considers that **access to law**, including legal information systems providing efficient and ergonomic search tools for access to EU legislation, contributes to the proper functioning and understanding of legislation at EU level. Additionally, clear and practical guidance explaining the implications of legislation for businesses and citizens in non legal terms contributes to the same goal.

### **Further work**

23. In order to provide for the Council's position on the Commission's Third Strategic Review and the actual developments in the Better Regulation agenda, the Presidency confirms its intention to prepare a set of draft **Council Conclusions** for the May meeting of the Competitiveness Council.
