amending Regulation (EEC) No 337/75
establishing a European Centre for the Development of Vocational Training

(presented by the Commission)

EXPLANATORY MEMORANDUM

By Regulation (EEC) No 337/75 of 10 February 1975, the Council established a European Centre for the Development of Vocational Training.

The Centre is administered by a Management Board comprising:

- a) representatives of the Member States,
- b) representatives of the employers' professional organizations,
- c) representatives of the employees' professional organizations,
- d) three members representing the Commission.

The members referred to in (a), (b), and (c) are appointed by the Council on the basis of one member per Member State for each of those groups.

In view of the enlargement of the European Union to include three new Member States, it is proposed that the Management Board include nine additional members, therefore bringing the total number of members to forty-eight.

THE COUNCIL OF THE EUROPEAN UNION

Having regard to the Treaty establishing the European Community,

Having regard to the Act of Accession of Norway, Austria, Finland and Sweden to the European Union, and in particular Article 169 thereof,

Having regard to the proposal from the Commission,

Whereas Regulation (EEC) No 337/75¹ established a European Centre for the Development of Vocational Training,

Whereas the management board of the above-mentioned Centre needs to be adapted to take into account the accession of the new member States;

HAS ADOPTED THIS REGULATION:

Article 1

Article 4, paragraph 1 of Regulation (EEC) No 337/75 shall be amended as follows:

- 1) In the first sentence "39 members" shall be replaced by "48 members".
- 2) In points a), b) and c) "12 members" shall be replaced by "15 members".

Article 2

This Regulation shall enter into force subject to, and on the date of, the entry into force of the Treaty of Accession of Norway, Austria, Finland and Sweden.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
