**COUNCIL DECISION**

on the conclusion of an Agreement in the form of an exchange of letters  
concerning the shortening by one year of the duration of the Agreement on relations  
in the sea fisheries sector between the European Economic Community  
and the Kingdom of Morocco

(presented by the Commission)



## **EXPLANATORY MEMORANDUM**

The fisheries agreement between the Community and Morocco was concluded in May 1992 for a period of four years, i.e. from 1 May 1992 to 30 April 1996.

Article 15(2) of the current agreement provides for a mid-term review to enable the parties to consider, after two years of application, implementation of the agreement and the fishing opportunities.

After three rounds of meetings as part of the mid-term review, the parties came to a deadlock. Morocco, referring to the present socio-economic crisis in its fisheries sector and its concern about overfishing, requested a substantial reduction in the fishing opportunities currently granted to the Community. In the Community's opinion, the reductions requested went way beyond the spirit and the letter of the Agreement.

At its meeting of 28 September 1994, the Council invited the Commission to initiate the procedures for entering into negotiations in order to ensure the continuation of fishing by Community vessels in waters under the sovereignty or jurisdiction of Morocco.

At a meeting within the framework of the mid-term review referred to in Article 15(2) of the Agreement held in Brussels on 13 October 1994, the two parties agreed to:

- terminate the mid-term review and limit the duration of the current Agreement to midnight on 30 April 1995. As a result, the last year of the Agreement will not be applied;
- enter into negotiations at the earliest opportunity on the possible conclusion of a new agreement for a period of three years from 1 May 1995.

For the above reasons, the Commission recommends that the Council should suspend the present Agreement from 1 May 1995 by means of an agreement in the form of an exchange of letters.

**THE COUNCIL OF THE EUROPEAN UNION,**

**Having regard to the Treaty establishing the European Community, and in particular Article 43 taken together with the first subparagraph of Article 223(3) thereof,**

**Having regard to the proposal from the Commission,**

**Having regard to the opinion of the European Parliament,**

**Whereas Article 15(2) of the Agreement on relations in the sea fisheries sector between the European Economic Community and the Kingdom of Morocco, concluded in 1992 for a period of four years, provides for a mid-term review;**

**Whereas in the framework of that review the two parties agreed on 13 October 1994 to limit the duration of the Agreement to midnight on 30 April 1995 and to enter into the necessary negotiations at the earliest opportunity with a view to the possible conclusion of a new agreement for a period of three years from 1 May 1995,**

**HAS DECIDED AS FOLLOWS:**

**Article 1**

**The Agreement in the form of an exchange of letters concerning the shortening by one year of the duration of the Agreement on relations in the sea fisheries sector between the European Economic Community and the Kingdom of Morocco is hereby approved on behalf of the Community.**

**The text of the Agreement is attached to this Decision.**

**Article 2**

**The President of the Council is hereby authorized to designate the persons empowered to sign the Agreement in order to bind the Community.**
