## EXPLANATORY MEMORANDUM

## Proposed amendments of the Council Decision 91/116/EEC setting up the European Advisory Committee on statistical information in the economic and social spheres

Council Decision 91/116/EEC established the European Advisory Committee on statistical information in the economic and social spheres. This advisory committee is organised with representatives from the scientific, economic and social field from the Member States, and the committee's main task is to help the Council and the Commission to coordinate the objectives of the Communty's statistical information polics.

In Article 4 of the said Council Decision 91/II6/EEC setting up the European Advisory Committee on statistical information in the economic and social spheres, the number of member of which the Committee shall consist, is specified by stating the numbers of representatives from the Member states to be represented.

By reason of the accession of Austria, Finland and Sivedenit is necessary to eliminate the discrepancy to the number of members of the Member States as concerns the number of Presidents or Director-Generals of the national statistical institutes (12) and the two representatives from each member State to be appointed by the Council (24)

In order to make the Council Decision more flexible, so as to meet future accessions of new Member States without the need to propose new amendments concerning the number of participants in the Committee, it is proposed to delete the reference to the exact number of members in Article 4.

- the Chairman of the Committee on Monetary, Financial and Balance of Payments Statistics;
- The Presidents or Directors-General of the national statistical institutes of the Nember States:
wo representatives per Member State appointed by the Council, after
