## EXPOSÉ DES MOTIFS

Suite à l'élargissement de la Communauté et en l'attente de l'adaptation des accords d'échanges préférentiels avec les pays d'Europe centrale et orientale, des mesures ont été adoptées pour permettre le maintien des flux d'échanges préférentiels entre les nouveaux États membres et les PECO. Ces mesures, qui ont été prises de façon autonome par la Communauté, sont contenues dans le règlement (CE) n°1767/95 du Conseil.

Le 1er juillet 1995, la Communauté a commencé à mettre en oeuvre les engagements qu'elle avait pris dans le domaine agricole au titre du GATT. Il en est résulté une augmentation des droits de douane pour certains produits agricoles transformés. Afin de maintenir les préférences octroyées aux PECO dans le cadre des accords, la Communauté a pris des mesures autonomes. Ces mesures autonomes, qui ont été élargies par les règlements (CE) n° 1534/96 devaient rester en vigueur jusqu'à ce que les accords applicables soient adaptés.

Eu égard au fait que l'adaptation des accords européens pourrait ne pas se faire d'ici au 31 décembre 1997, et pour éviter toute détérioration de l'accès au marché communautaire pour les produits faisant l'objet d'accords préférentiels provenant des PECO, les mesures visées dans les règlements précités doivent être prolongées jusqu'au 30 juin 1997.

La présente proposition n'entraîne aucune autre dépense supplémentaire que celles déjà acceptées lors de l'adoption des règlements qu'elle remplacera.

Pour ces raisons, la Commission propose au Conseil d'adopter le règlement suivant.

**THE COUNCIL OF THE EUROPEAN UNION,**

Having regard to the Treaty establishing the European Community, and in particular Article 113 thereof,

Having regard to the proposal from the Commission,

Having regard to the Act of Accession of Austria, Finland and Sweden,

Whereas, pending adaptation of Protocol 3 of the Europe Agreements concluded with Poland, Hungary, Slovakia, the Czech Republic, Romania and Bulgaria<sup>1</sup>, Council Regulation (EC) No 1534/96<sup>2</sup> was adopted, which, until 31 December 1996 maintains the degree of preference granted, thus offsetting possible negative effects the implementation of the results of the Uruguay Round may have on exports of these countries to the Community;

Whereas the negotiations which are currently under way with the countries concerned for the conclusion of Protocols amending the Europe have not yet been concluded; whereas 'interim' Protocols covering solely the trade-related aspects of the amending protocols cannot enter into force on 1 January 1997; whereas it is therefore advisable to extend the concessions on an autonomous basis until 30 June 1997;

Whereas adoption of this Regulation has rendered obsolete the provisions of Regulation (EC) No 3380/94 of 22 December 1994 opening and providing for the administration of quotas for certain processed agricultural products originating in Hungary<sup>3</sup>

## **Article 1**

1. From 1 January to 30 June 1997, the basic amounts to be taken into account in the calculation of the reduced agricultural components and the reduced additional duties applicable at importation into the Community of goods originating in Poland, Hungary, Slovakia, the Czech Republic, Romania, Bulgaria and listed in Annex I to this Regulation shall be those mentioned in the Annex II. The reduced agricultural components apply within the annual quotas set out in Annex I.
2. From 1 January to 30 June 1997, the processed agricultural products originating in Poland, Hungary, Slovakia, the Czech Republic, Romania, Bulgaria and listed in Annex III to this Regulation shall be subject to the duties provided for in that annex.

## **Article 2**

The quotas referred to in Annex I to this Regulation shall be administered by the Commission in accordance with the provisions of Regulation (EC) No 1460/96 establishing the detailed rules for implementing the preferential trade arrangements applicable to certain goods resulting from the processing of agricultural products, as provided for in Article 7 of Regulation (EC) No 3448/93<sup>4</sup>.

## **Article 3**

If the countries mentioned in Article 1 do not apply reciprocal measures in favour of the Community, the Commission may, in accordance with the procedure foreseen in Article 16 of Regulation (CE) No 3448/93<sup>5</sup>, suspend the measures provided for in Article 1 to the present Regulation.

## **Article 4**

Regulation (EC) No 3380/94 is hereby repealed.

## **Article 5**

This Regulation shall enter into force on the third day after its publication in the Official Journal of the European Communities.

It shall apply with effect from 1 January 1997.
