# Recommendation for a Council Decision

authorising the Commission to open negotiations with Romania for the conclusion of an agreement on trade in textiles

(submitted to the Council by the Commission)

### Explanatory Memorandum

1. The Community is a party to the Arrangement Regarding International Trade in Textiles (M.F.A.). Article 4 of this Arrangement leaves open the possibility for participating countries to conclude bilateral agreements between importing and exporting countries. The Community was of the opinion that it was through the conclusion of such agreements with its principal suppliers that the principal objective of the M.F.A., i.e. the orderly development of trade in textiles, could best be achieved.

In accordance with this view, negotiations were initiated first with those third countries with which the Community had already concluded agreements on trade in cotton textiles.

2. At its meeting on 12 March 1975 the Committee of Permanent Representatives decided that negotiations should also be proposed by the Community to the three state-trading countries which are parties to the M.F.A.-Hungary, Poland and Romania (without prejudice to possible negotiations for global trade agreements). It also agreed the text of a letter to be addressed by the Commission to the three countries indicating the willingness of the Community to open negotiations which, "while taking account of the differences in commercial structures, would be based on the provisions of Article 4 of the M.F.A." (see text of letter in Annex A).

On 8 January 1976 the Romanian authorities replied that they were prepared to open negotiations with the Community based on Article 4 of the M.F.A. and also taking account of Articles 2 and 6 (see text of letter in Annex B).

By contrast, Poland and Hungary have not replied to the Community's offer. The Commission considers, consequently, that the import rules at present applied with regard to those countries, in conformity with the provisions of the GATT, including the protocols of accession, should remain in effect.

3. In view of the time-limit fixed in the M.F.A. for the conclusion of bilateral agreements (31 March 1976) and in view also of the favourable response from Romania to the Community offer, the Commission is of the opinion that negotiations with Romania should be opened as quickly as possible. In unofficial conversations between the Commission's services and the Romanian authorities and in meetings of the Council's textile group on the preparation of possible negotiations with the state-trading countries certain elements which could serve as a basis for the negotiations have emerged.

In the light of these elements and in view of the provisions and obligations of the M.F.A., the Commission considers that the negotiations with Romania should be governed by the same criteria as the other negotiations which have already taken place, with the exception of those items which are necessary to take account of the differences in commercial structures mentioned in the Commission's letter, cited above at point 2.

On the internal level, the provisions adopted for the preceding negotiations, particularly burden-sharing should apply.

4. Consequently, the Commission recommends to the Council, by virtue of Article 113 of the Treaty, that it adopt the attached Decision.

Recommendation for a Council Decision authorising the Commission to open negotiations with Romania for the conclusion of an agreement on trade in textiles

THE COUNCIL OF THE EUROPEAN COMMUNITIES.

Having regard to the Treaty establishing the European Economic Community, and in particular Article 113 thereof,

Having regard to the recommendation from the Commission,

Whereas Article 4 of the Arrangement Regarding International Trade in Textiles permits the conclusion of bilateral agreements between importing and exporting countries;

Whereas the Community considers that the conclusion of such agreements with the third countries which are its principal suppliers would best enable it to achieve the objectives of the said Arrangement Regarding International Trade in Textiles;

Whereas the Community therefore proposed to Romania, a party to the said Arrangement, the opening of negotiations for the conclusion of an agreement on trade in textiles and whereas Romania has replied favourably,

HAS ADOPTED THIS DECISION:

#### Article 1

The Commission is hereby authorised to open negotiations with Romania with a view to the conclusion of an agreement on trade in textile products, in accordance with the provisions of the Arrangement Regarding International Trade in Textiles.

Article 2

The Commission shall conduct such negotiations in consultations with the special Article 113 Committee and on the basis of the directives in the Annex hereto.

### Directives for negotiations with Romania

- I. Items identical with those adopted with regard to all the countries with which the Community has negotiated.
  - a) Autolimitation agreement, valid until 31 December 1977, with an administration system which includes double-checking.
  - b) Coverage of the agreement established selectively on the basis of the criteria in Article 4 of the M.F.A.: elimination of real risks of market disruption and the fixing of ceilings based on that concept.
  - c) Binding consultation clause and regional measures.
  - d) Provisions for flexibility, carry-over and anticipation.

#### II. Additional items

- a) Inclusion of linen in the coverage of the agreement.
- b) Provisions relating to outward processing traffic: of the kind adopted for Yugoslavia.
- III. Specific items flowing from the differences in commercial structures.
  - a) A price clause allowing account to be taken of the particular methods of price-formation in Romania and giving to the Community the possibility of intervening in case products covered by the agreement should be offered for sale at prices considerably below:
    - the price of the national product at the same level of trade
    - and the price generally prevailing for exports by other countries to the importing market.
  - b) Market access for Community textile products: an undertaking to be given by Romania to diversify and increase its imports of textile products from the Community.
