extending to the periods 1991/92 and 1992/93 the increase adopted for the periods 1993/94 and 1994/95 in the total quantities fixed for Greece, Spain and Italy under the system for the additional levy in the milk and milk products sector

EXPLANATORY MEMORANDUM

Under the terms of the common conclusions dated 21 October 1994, the Council and the Commission adopted the measures to be taken by the institutions on the one hand, and by the Member States concerned on the other hand, to settle, within the framework of the milk quota system, the clearance of accounts for the five periods 1988/89 to 1992/93 in respect of Spain, Italy and Greece.

The Council agreed, for these three Member States, to extend its decisions on the increase in milk quotas as from 1 April 1993 to the two previous periods 1991/92 and 1992/93.

This Regulation is the Commission proposal relating thereto.

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty establishing the European Community, and in particular Article 43 thereof,

Having regard to the proposal from the Commission<sup>1</sup>,

Having regard to the opinion of the European Parliament<sup>2</sup>,

Whereas the Council has decided to increase the total quantities fixed in Article 3(2) of Council Regulation (EEC) No 3950/92 of 28 December 1992 establishing an additional levy in the milk and milk products sector<sup>3</sup>, as last amended by Regulation (EC) No 1883/94<sup>4</sup>, in the case of Spain from the period 1993/94 and in the case of Greece and Italy for the periods 1993/94 and 1994/95; whereas the consequences to be drawn therefrom for the clearance of accounts for 1992 and 1993 make it necessary to extend the aforementioned increase to the periods 1991/92 and 1992/93,

HAS ADOPTED THIS REGULATION:

Article 1

For the establishment of the financial corrections relating to the clearance of accounts for 1992 and 1993 borne by Greece, Spain and Italy in respect of the additional levy in the milk and milk products sector, the total quantities to be taken into consideration for the periods from 1 April 1991 to 31 March 1992 and from 1 April 1992 to 31 March 1993 shall be those fixed in Article 3(2) of Regulation (EEC) No 3950/92.

Article 2

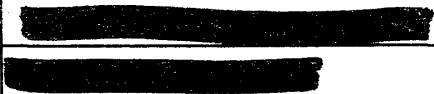
This Regulation shall enter into force on the third day following its publication in the Official Journal of the European Communities.
