EXPLANATORY NOTE

Subject: Draft regulation of the Council modifying Annex I of Regulation (EEC)
No 865/68 concerning certain products of the subposition 20.06 B II
of the Common Customs Tariff

As a result of the negotiations carried out pursuant to Article 12.77, paragraph 6 of the General Agreement on Tariffs and Trade, the European Community has undertaken to reduce certain customs duties from 1st January 1975 and at the same time to modify the nomenclature of the Common Customs Tariff.

For products processed from fruit and vegetables, certain products of Chapter 20 are concerned.

By consequence, for the products in question which appear in Annex I of Regulation (NEC) No 865/68 the present draft regulation foresees an adaptation to the nomenclature of the Common Customs Tariff.

RECULATION (EEC)

OF THE COUNCIL

amending Annex 1 to Regulation (EEC) No 865/68 as regards certain products falling within subheading No 20.06 B II of the Common Customs Tariff

THE COUNCIL OF THE EUROPEAN COMMUNITIES

Having regard to the Treaty establishing the European Economic Community;

Having regard to Council Regulation (EEC) No 865/68(1) of June 1968 on the common organization of the market in products processed from fruit and vegetables, as last amended by Regulation (EEC) No 2429/72(2), and in particular Article 2(1) thereof;

Having regard to the proposal from the Commission;

Whereas as a result of the Agreement concluded by the Council Decision of 20 July 1974 following the negotiations carried out pursuant to Article XXIV(6) of the General Agreement on Tariffs and Trade the nomenclature of the Common Customs Tariff has been amended as regards vertain products of Chapter 20; whereas part of that nomenclature is for the purposes of the levy in respect of various added sugars incorporated in Annex 1 to Regulation (EEC) No 865/68; whereas it is therefore necessary to amend that Annex accordingly;

HAD ADOPTED THIS REGULATION :

Article 1

As regards products following within subheading No. 20.06 B II, the text of Amnex I to Regulation (EEC) No 865/68 is replaced by that set out in the Annex to this Regulation.

Article 2

This Regulation shall enter into force on the third day following its publication in the Official Journal of the European Communities. It shall apply with effect from 1 January 1975.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
