THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic  
Community;

Having regard to the Treaty (1) concerning the Accession of new Member  
States to the European Economic Community and to the European Atomic  
Energy Community, signed at Brussels on 22 January 1972, and in parti-  
cular Articles 47 (5) and 97 of the Act annexed hereto, hereinafter referred  
to as "the Act".

Having regard to the proposal from the Commission;

Whereas Article 97 of the Act provides that accession compensatory  
amounts are to be determined in accordance with the rules applicable  
for the calculation of the refunds provided for in Regulation (EEC)  
No 204/69 (2); whereas the latter Regulation has been replaced by  
Regulation (EEC) 2682/72; and whereas the first subparagraph of  
Article 4 (1) of that Regulation provides that such refunds are to  
be fixed on a monthly basis;

Whereas in the case of cereals or rice exported unprocessed the compensatory amounts may be varied during a given month under Article 7 of Council Regulation (EEC) No 229/73 (3) or under Article 5 of Council Regulation (EEC) No 243/73 (4);

Whereas it is unnecessary to follow the daily movements of prices of cereals or rice exported unprocessed if they are exported in the form of goods covered by Regulation (EEC) No 26 2/72, and whereas it is appropriate to apply the principle of monthly fixing in respect of compensatory amounts applicable to the export of these goods;

Whereas it is necessary to specify the method of calculation of such monthly compensatory amounts;

HAS ADOPTED THIS REGULATION :

Article 1

1. If in any month Article 7 of Regulation (EEC) No 229/73, or Article 5 of Regulation (EEC) No 243/73, is applied for one or more days, the amount applicable the following month by way of compensatory amount in respect of cereals or rice exported in the form of goods covered by Regulation (EEC) No 2682/72 shall be determined on a monthly basis by reference to the average of the amounts determined during the first 25 days of the previous month for the cereals or rice in question exported unprocessed.
2. However, if the amount varied by less than 5% from the amount determined for the previous month, it shall remain unaltered.

Article 2

This Regulation shall enter into force on the day of its publication in the Official Journal of the European Communities.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
