REGULATION (EEC) OF THE COUNCIL

maintaining in effect the interim measures adopted  
with regard to imports of certain textile products  
originating in the Republic of Korea

Explanatory Memorandum

1. By Regulation (EEC) No. 3351/75 of 22 December 1975<sup>(1)</sup> the Commission established interim measures with regard to imports of certain textile products originating in the Republic of Korea.
2. These measures permit a mutual verification of trade in the products covered by the Agreement with Korea initialled on 28 November 1975 in order that the Agreement may, in accordance with the terms thereof, apply to all trade carried on in 1976.
3. The Commission considers that it is necessary to maintain this system in effect, until the entry into force of the Council Regulation applying the import rules provided for in the Agreement between the EEC and the Republic of Korea, or, in default, until the adoption by the Council of other appropriate measures.
4. In accordance with the provisions of Article 12(6) of Regulation (EEC) No. 1439/74 the Commission therefore submits to the Council the attached proposed Regulation concerning appropriate measures to be taken in this matter.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 1439/74 of 4 June 1974  
on common rules for imports<sup>(1)</sup>, and in particular Article 13 thereof,

Having consulted the Committee provided for in Article 5 of the said  
Regulation,

Having regard to the proposal from the Commission;

Whereas by Regulation (EEC) No 3351/75<sup>(2)</sup> of 22 December 1975 the  
Commission established interim measures with regard to imports of  
certain textile products originating in the Republic of Korea;

Whereas the reasons which justified the establishment of such measures  
still exist and they should therefore be maintained in force

until the entry into force of the Council Regulation applying  
the import rules resulting from the conclusion of the Agreement initialled  
on 28 November 1975 between the European Economic Community and the  
Republic of Korea on Trade in Textiles, or, in default thereof, of other  
appropriate measures to be taken by the Council,

HAS ADOPTED THIS REGULATION :

Article 1

1. The interim measures adopted by Commission Regulation (EEC) No 3351/75 of 22 December 1975 with regard to imports of certain textile products originating in the Republic of Korea shall continue to apply temporarily.

2. This Regulation shall enter into force on the day following its publication in the Official Journal of the European Communities.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
