REGULATION (EEC) OF THE COUNCIL

maintaining in effect the interim measures adopted with regard to imports of certain textile products originating in the Federal Republic of Brazil

(submitted to the Council by the Commission)

Explanatory Memorandum

- 1. By Regulation (EEC) No. 3355/75 of 23 December 1975⁽¹⁾ the Commission established interim measures with regard to imports of certain textile products originating in the Federative Republic of Brazil.
- 2. These measures permit a mutual verification of trade in the products concerned in the negotiations in course with Brazil in order that the Agreement which may be concluded may apply to trade carried on in 1976.
- 3. The Commission considers that it is necessary to maintain this system in effect, until the entry into force of the Council Regulation applying the import rules which may result from the Agreement to be negotiated between the EEC and Brazil, or, in default, until the adoption by the Council of other appropriate measures.
- 4. In accordance with the provisions of Article 12(6) of Regulation (EEC) No. 1439/74 the Commission therefore submits to the Council the attached proposed Regulation concerning appropriate measures to be taken in this matter.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 1439/74 of 4 June 1974 on common rules for imports (1) and in particular Article 13 thereof,

Having consulted the Committee provided for in Article 5 of the said Regulation,

Having regard to the proposal from the Commission,

Whereas by Regulation (EEC) No 3355/75⁽²⁾ of 23 December 1975 the Commission established interim measures with regard to imports of certain textile products originating in the Federal Republic of Brazil;

Whereas the reasons which justified the establishment of the said measures still exist and they should therefore be maintained in force until the entry into force of the Council Regulation applying the import rules which may result from the Agreement to be negotiated between the European Economic Community and the Federal Republic of Brazil on Trade in Textiles, or, in default thereof, of other appropriate measures to be taken by the Council,

HAS ADOPTED THIS REGULATION:

Article 1

- 1. The interim meausres adopted by Commission Regulation (EEC)
 No 3355/75 of 23 December 1975 with regard to imports of certain
 textile products originating in the Federal Republic of Brazil shall
 continue to apply temporarily.
- 2. This Regulation shall enter into force on the day following its publication in the Official Journal of the European Communities.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
