## COUNCIL REGULATION

amending Regulation (EEC) No 3017/79 on protection  
against dumped or subsidized imports from countries

EXPLANATORY MEMORANDUM

On 20 December 1979 the Council adopted Regulation (EEC) 3017/79 on protection against dumped or subsidised imports from countries not members of the European Economic Community. Article 14 of that Regulation provides for the possibility of a review of measures taken by the Community institutions and lays down that such a review may be held if an interested party so requests and submits positive information substantiating the need for review.

Since, however, anti-dumping and countervailing measures are taken only after a lengthy, costly and formal investigation it is proposed to lay down a minimum period which must elapse after the conclusion of a proceeding before a review is held at the request of interested parties. The possibility of a review at the request of a Member State or on the initiative of the Commission would remain unchanged.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,  
and in particular Article 113 thereof,

Having regard to the Regulations establishing the common organization of  
agricultural markets and the Regulations adopted under Article 235 of the  
Treaty, applicable to goods manufactured from agricultural products, and  
in particular the provisions of those Regulations which allow for derogation  
from the general principle that protective measures at frontiers may be  
replaced solely by the measures provided for in those Regulations,

Having regard to the proposal from the Commission,

Whereas by Regulation (EEC) No 3017/79(1) the Council adopted Community rules and  
procedures for protection against dumped or subsidized imports from countries  
which are not members of the European Economic Community;

Whereas Article 14 of the said Regulation provides for the possibility  
of a review of measures taken by the Community institutions

and, in order to enable parties to protect their interests,  
lays down in particular that such review may be held if an  
interested party so requests and submits positive information substantiating  
the need for review;

Whereas, however, anti-dumping and countervailing measures are taken only  
after a formal investigation which is both costly and time-consuming and  
which offers full opportunities for all parties to make known their views;

Whereas, therefore, in order to avoid abuse of Community procedures and  
resources it is appropriate to amend the provisions governing reviews

requested by interested parties so as to lay down a minimum period which must elapse after the conclusion of a proceeding before such a review will be held,

HAS ADOPTED THIS REGULATION:

Article 1

Article 14(1) of Regulation (EEC) No 3017/79 is hereby replaced by the following:

"1. The Regulations imposing anti-dumping or countervailing duties and the decisions to accept undertakings shall be subject to review where warranted. Such review may be held either at the request of a Member State or on the initiative of the Commission. A review shall also be held where an interested party so requests and submits evidence sufficient to justify such a review, provided that at least one year has elapsed since the conclusion of the proceeding. Such requests shall be addressed to the Commission which shall inform the Member States."

Article 2

This Regulation shall enter into force on the third day following that of its publication in the Official Journal of the European Communities.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
