PROPOSAL FOR A COUNCIL REGULATION (EEC)

on the autonomous and special arrangements for beef and veal products originating in some signatory States of the ACP-CEM Convention of Lomé

EXPLANATORY MEMORANDUM

- 1. In accordance with the declaration of intent regarding beef made by the Community upon the signature of the ACP-EEC Lomé Convention on 28 February 1975, the Community introduced special short term provisions to allow ACP beef exporting States to maintain their exports to the Community (27.532 tons per annum) despite the problems this sector is experiencing in the Community. These provisions, the period of validity having been extended upon three occasions, expire on 31 December 1976.
- 2. Experience obtained since the entry into force of the Convention and data gathered, show that these measures were fully justified to allow the countries in question to maintain their exports and thereby to provide a certain revenu for the producers. Nonetheless, because of the short duration of these provisions (six months) certain problems have arisen, notably for production plans for subsequent export to the Community and also for transport and sales arrangements. The problem is most acute for Botswana. For this country its geographic position and the political events in neighbouring regions give rise to additional problems, especially of transport. In normal circumstances a delay of at least six weeks is already necessary to ensure the transportation of beef to the Community.
- 3. For these reasons and in view of the declared intentions made upon the signature of the Lomé Convention, it is proposed to maintain, with some adjustments the special provisions currently applied. The attached proposed regulation provides for such steps. Principally the proposal is that the provisions are valid for 18 months, this period being compensated for by a progressive reduction in the adventages of the reduced import charges other than customs duties.

THE COUNCIL OF THE EUROPEAN COLMUNITIES.

Having regard to the Treaty establishing the European Economic Community and in particular Article 43 thereof;

Having regard to the proposal from the Commission;

Having regard to the opinion of the European Parliament (1);

Whereas some signatory States of the ACP-EEC Convention of Lomé (2) are traditional suppliers of beef to the Community; whereas the production of this product is an essential factor of their economies which are closely linked with this kind of exports; whereas the States in question being the least developed among the States exporting beef to the Community special measures might contribute to maintain a regular flow of imports;

Whereas Council Regulation (EEC) No 3328/75 (3) renewing the arrangements for the reduction of import charges on beef and veal products originating in the African, Caribbean and Pacific States as last amended by Regulation (EEC) No 1466/76 (4), which follows a transfer to Botswana, Kenya, Madagascar and Swaziland of the amounts of reduction of import charges other than customs duties for the products referred to in the first article under a) of Council Regulation (EEC) No 805/68 (5) of 27 June 1968 on the common organisation of the market in beef and veal, at last amended by Regulation (EEC) No 568/76 (6) has taken into account this situation, that the arrangements established by this regulation expire 31 December 1976;

Whereas to take into account the vital importance which the beef sector has for the abovementioned countries and to remove at the same time some difficulties encountered during the first periods of application of the special arrangements, these measures should be extended with some adjusments involving especially a longer period of validity of the arrangements and a slight decrease of the amounts of reduction of the import charges;

HAS ADOPTED THIS REGULATION:

Article 1

The charges on imports of the products originating in some signatory States of the ACP-PEC Convention of Lomé referred to in Article 1 (a) of Regulation (EEC) No 805/68 shall be reduced under the conditions provided for by this regulation.

Article 2

The amount of reduction in charges on import correspond to

- a) 85 % during the period from 1 January until 30 June 1977,
- b) 80 % during the period from 1 July until 31 December 1977,
- c) 75 % during the period from 1 January until 30 June 1978
- of the average of the import charges applicable during a reference period. It is fixed quarterly by the Commission.

Article 3

The reduction of charges are limited to the following quantities, expressed in terms of boneless meat:

For the application of this regulation 100 kilogrammes of boneless meat correspond to 130 kilogrammes of bone-in meat.

Article 4

The reduction of the charges on imports shall apply only to imports for which the importer proves that an export tax of an amount corresponding to the reduction has been charged by the exporting country.

Article 5

Detailed rules for the application of this regulation shall be adopted in accordance with the procedure provided for in Article 27 of the Regulation (EEC) No 805/68.

Under the same procedure derogation may be made from the principle of quarterly fixing and from the rules concerning the reference period if a change in the representative rate of the currency of a Member State or the transition from one marketing year to the next so requires.

Article 6

This Regulation shall enter into force on 1 January 1977.

This Regulation shall be binding in tis entirety and directly applicable in all Member States.
