EUROPEAN SOCIAL FUND - ACTIVITIES IN 1963

In December 1963 the Commission approved seven refund applications submitted by Germany (F.R.), France, Italy and the Netherlands. The refunds granted by these new decisions total 5 717 477 u.a.

For 1963 this brings the total aid from the Fund to 7 561 477 u.a., allocated as follows:

Under the schemes for which refunds have been granted in 1963, about 80 500 workers have found new jobs after retraining or resettlement.

The total aid granted by the European Social Fund after three years of operation is 19 853 275 u.a.; the schemes for which refunds have been granted have helped 263 500 workers (Germany (F.R.), 38 500 + 35 740 Italian workers resettled; Belgium, 2 400; France, 15 050; Italy, 167 200; Netherlands, 4 600).
