GRANTS OF £11 961 183FOR AGRICULTURAL AND FISHERIES INVESTMENT

Second FEOGA Allocation for 1986

The European Commission has announced grants totalling £11 961 183 for 64 projects for the improvement of processing in agricultural and fishery products. The grants are additional to national aid.

Regulation 355/77 provides EEC farm fund money to finance improvements in certain agricultural sectors through programmes agreed between the Government and the Commission. Processing and marketing projects in the fisheries sector are also supported under this regulation.

The projects marked with an asterisk (*) are supported under Regulation 1943/81 designed to improve the processing and marketing conditions in the cattlefeed sector in Northern Ireland.
