'The European Parliament,

- A. aware of and welcoming the achievements of all those concerned in reaching agreement on the new Common Fisheries Policy,
- B. aware that the new Common Fisheries Policy must now achieve its objectives by ensuring the conservation of stocks and the effective management of the Community fisheries,
- C. aware that the aim of the Commission is to ensure the rapid, efficient, and effective introduction of the new Policy,
- D. aware that, in order to be effective, the Common Fisheries Policy must have the confidence and support of the fishermen and the industry,
- E. aware that the Fisheries Directorate-General will require a significant expansion to achieve those aims,
- F. aware that the Commission intends shortly to submit a supplementary budget for reorganising the Fisheries Directorate-General.
- G. concerned that the administrative structure of the Fisheries Directorate-General should reflect the most advanced professional fisheries management expertise available in the Community,
- Calls on the Commission to ensure that full cooperation takes place on fisheries' matters between Member States, the Commission, the Parliament, and the fishing industry;
- 2. Wishes to emphasise that the Fisheries Directorate-General must be adequately staffed at all levels and in all relevant disciplines to carry out the necessary tasks;
- 3. Requests the Commission to coordinate all fisheries matters, including the relevant aspects of EAGGF, regional policy, and social policy within the Fisheries Directorate-General and to ensure that decisions on important practical measures such as TAC allocations take place before the commencement of the fishing season;
- 4. Requests that the necessary administrative measures be taken urgently and recommends that advice be sought from the national fisheries administrations. Furthermore requests that representatives of the working fishermen be consulted;
- 5. Instructs its President to forward this resolution to the Commission and the Council of Ministers.'
