36. Declaration on the Overseas Countries and Territories

The Conference recognises that the special arrangements for the association of the overseas countries and territories (OCTs) under Part Four of the Treaty establishing the European Community were designed for countries and territories that were numerous, covered vast areas and had large populations. The arrangements have changed little since 1957.

The Conference notes that there are today only 20 OCTs and that they are extremely scattered island territories with a total population of approximately 900 000. Moreover, most OCTs lag far behind in structural terms, a fact linked to their particularly severe geographical and economic handicaps. In these circumstances, the special arrangements for association as they were conceived in 1957 can no longer deal effectively with the challenges of OCT development.

The Conference solemnly restates that the purpose of association is to promote the economic and social development of the countries and territories and to establish close economic relations between them and the Community as a whole.

The Conference invites the Council, acting in accordance with the provisions of Article 136 of the Treaty establishing the European Community, to review the association arrangements by February 2000, with the fourfold objective of:

- promoting the economic and social development of the OCTs more effectively;
- developing economic relations between the OCTs and the European Union;
- taking greater account of the diversity and specific characteristics of the individual OCTs, including aspects relating to freedom of establishment;
- ensuring that the effectiveness of the financial instrument is improved.

PART FOUR

ASSOCIATION OF THE OVERSEAS
COUNTRIES AND TERRITORIES

Article 131

The Member States agree to associate with the Community the non-European countries and territories which have special relations with Belgium, Denmark,* France, Italy, the Netherlands and the United Kingdom.** These countries and territories (hereinafter called the 'countries and territories') are listed in Annex IV to this Treaty.

The purpose of association shall be to promote the economic and social development of the countries and territories and to establish close economic relations between them and the Community as a whole.

In accordance with the principles set out in the Preamble to this Treaty, association shall serve primarily to further the interests and prosperity of the inhabitants of these countries and territories in order to lead them to the economic, social and cultural development to which they aspire.

Article 132

Association shall have the following objectives.

1. Member States shall apply to their trade with the countries and territories the same treatment as they accord each other pursuant to this Treaty.

2. Each country or territory shall apply to its trade with Member States and with the other countries and territories the same treatment as that which it applies to the European State with which it has special relations.

3. The Member States shall contribute to the investments required for the progressive development of these countries and territories.

4. For investments financed by the Community, participation in tenders and supplies shall be open on equal terms to all natural and legal persons who are nationals of a Member State or of one of the countries and territories.

5. In relations between Member States and the countries and territories the right of establishment of nationals and companies or firms shall be regulated in accordance with the provisions and procedures laid down in the Chapter relating to the right of establishment and on a non-discriminatory basis, subject to any special provisions laid down pursuant to Article 136.

Article 133

1. Customs duties on imports into the Member States of goods originating in the countries and territories shall be completely abolished in conformity with the progressive abolition of customs duties between Member States in accordance with the provisions of this Treaty.

2. Customs duties on imports into each country or territory from Member States or from the other countries or territories shall be progressively abolished in accordance with the provisions of Articles 12, 13, 14, 15 and 17.

3. The countries and territories may, however, levy customs duties which meet the needs of their development and industrialization or produce revenue for their budgets.

The duties referred to in the preceding subparagraph shall nevertheless be progressively reduced to the level of those imposed on imports of products from the Member State with which each country or territory has special relations. The percentages and the timetable of the reductions provided for under this Treaty shall apply to the difference between the duty imposed on a product coming from the Member State which has special relations with the country or territory concerned and the duty imposed on the same product coming from within the Community on entry into the importing country or territory.

4. Paragraph 2 shall not apply to countries and territories which, by reason of the particular international obligations by which they are bound, already apply a non-discriminatory customs tariff when this Treaty enters into force.

5. The introduction of or any change in customs duties imposed on goods imported into the countries and territories shall not, either in law or in fact, give rise to any direct or indirect discrimination between imports from the various Member States.

Article 134

If the level of the duties applicable to goods from a third country on entry into a country or territory is liable, when the provisions of Article 133(1) have been applied, to cause deflections of trade to the detriment of any Member State, the latter may request the Commission to propose to the other Member States the measures needed to remedy the situation.

Article 135

Subject to the provisions relating to public health, public security or public policy, freedom of movement within Member States for workers from the countries and territories, and within the countries and territories for workers from Member States, shall be governed by agreements to be concluded subsequently with the unanimous approval of Member States.

Article 136

For an initial period of five years after the entry into force of this Treaty, the details of and procedure for the association of the countries and territories with the Community shall be determined by an Implementing Convention annexed to this Treaty.

Before the Convention referred to in the preceding paragraph expires, the Council shall, acting unanimously, lay down provisions for a further period, on the basis of the experience acquired and of the principles set out in this Treaty.

The provisions of Articles 131 to 136 shall apply to Greenland, subject to the specific provisions for Greenland set out in the Protocol on special arrangements for Greenland, annexed to this Treaty.

PART FOUR

ASSOCIATION OF THE OVERSEAS COUNTRIES AND TERRITORIES

Article 182 (ex Article 131)

The Member States agree to associate with the Community the non-European countries and territories which have special relations with Denmark, France, the Netherlands and the United Kingdom. These countries and territories (hereinafter called the 'countries and territories') are listed in Annex II to this Treaty.

The purpose of association shall be to promote the economic and social development of the countries and territories and to establish close economic relations between them and the Community as a whole.

In accordance with the principles set out in the Preamble to this Treaty, association shall serve primarily to further the interests and prosperity of the inhabitants of these countries and territories in order to lead them to the economic, social and cultural development to which they aspire.

Article 183 (ex Article 132)

Association shall have the following objectives.

- (1) Member States shall apply to their trade with the countries and territories the same treatment as they accord each other pursuant to this Treaty.
- (2) Each country or territory shall apply to its trade with Member States and with the other countries and territories the same treatment as that which it applies to the European State with which it has special relations.
- (3) The Member States shall contribute to the investments required for the progressive development of these countries and territories.
- (4) For investments financed by the Community, participation in tenders and supplies shall be open on equal terms to all natural and legal persons who are nationals of a Member State or of one of the countries and territories.
- (5) In relations between Member States and the countries and territories the right of establishment of nationals and companies or firms shall be regulated in accordance with the provisions and procedures laid down in the Chapter relating to the right of establishment and on a non-discriminatory basis, subject to any special provisions laid down pursuant to Article 187.

Article 184 (ex Article 133)

Customs duties on imports into the Member States of goods originating in the countries and territories shall be prohibited in conformity with the prohibition of customs duties between Member States in accordance with the provisions of this Treaty.

2. Customs duties on imports into each country or territory from Member States and the other countries or territories shall be prohibited in accordance with the provisions of Article 25.

3. The countries and territories may, however, levy customs duties which meet their needs for their development and industrialisation or produce revenue for their budgets.

The duties referred to in the preceding subparagraph may not exceed the level of duties imposed on imports of products from the Member State with which each country or territory has special relations.

4. Paragraph 2 shall not apply to countries and territories which, by reason of their international obligations by which they are bound, already apply a non-discriminatory tariff.

5. The introduction of or any change in customs duties imposed on goods imported from the countries and territories shall not, either in law or in fact, give rise to any direct discrimination between imports from the various Member States.

Article 185 (ex Article 134)

If the level of the duties applicable to goods from a third country on entry into a territory is liable, when the provisions of Article 184(1) have been applied, to cause a restriction of trade to the detriment of any Member State, the latter may request the Commission to propose to the other Member States the measures needed to remedy the situation.

Article 186 (ex Article 135)

Subject to the provisions relating to public health, public security or public policy, the free movement within Member States for workers from the countries and territories, and the countries and territories for workers from Member States, shall be governed by the same agreements to be concluded subsequently with the unanimous approval of Member States.

Article 187 (ex Article 136)

The Council, acting unanimously, shall, on the basis of the experience acquired in the association of the countries and territories with the Community and of the principles laid down in this Treaty, lay down provisions as regards the detailed rules and the procedures for the association of the countries and territories with the Community.

Article 188 (ex Article 136a)

The provisions of Articles 182 to 187 shall apply to Greenland, subject to the special provisions for Greenland set out in the Protocol on special arrangements for Greenland annexed to this Treaty.

STATEMENTS

Statement by the Council and the Commission re Article 108(2)(a)

On the basis of a study, once the OCT have supplied the requisite information during consultations within the framework of the partnership arrangement set forth in part V of the Decision, the Commission will submit to the Council the proposal referred to in Article 108(2)(a) after consulting the Origin Section of the Customs Committee, by 31 December 1998. The Council will examine the proposal with dispatch, giving due weight to the conclusions of the Essen European Council on the harmonization of rules of origin.

Commission statement re Article 108a of the revised Decision

1. During the first five working days of January, import licences for OCTs may be requested for a quantity of 35 000 tonnes expressed as husked rice equivalent. The non-requested quantities may be requested during the first five working days of May and September respectively, if appropriate increased by the quantities referred to in Article 108a(2) and (3).
2. The ACP quota of 125 000 tonnes expressed as husked rice equivalent ⁽¹⁾ will be divided into three parts of 41 666 tons to be opened in January, May and September respectively.

As regards the quantities of each part not requested during the first five working days of January and May respectively, ACP import licences and OCT import licences may be requested during the first five working days of May and September respectively.

3. During the first five working days of October, the following may be requested:

- ACP or OCT import licences for the non-requested quantities under the 125 000 tonnes ACP quota;
- OCT import licences for the non-requested OCT quantities (35 000 tonnes, if appropriate increased by the quantities referred to in Article 108a(2) and (3)).

There will be appropriate consultations with the ACP States on the above mechanism prior to implementation.

Council statement re Article 108a(3)

The Council notes a Commission statement to the effect that only if it has first noted a genuine rice shortage on the Community market will the Commission possibly propose additional quantities of rice after the summer.

Council and Commission statement re Article 240(4)

"The Council and the Commission note that, according to Article 136 of the Treaty, the Council is required to adopt Decisions on the association of the OCT designed to achieve finally the objectives set out in Article 132 of the Treaty.

The Council and the Commission draw attention to the declaration concerning the OCT to be inserted into the Final Act of the Amsterdam Treaty, which invites the Council, acting in accordance with the provisions of Article 136 of the Treaty, to review these association arrangements by February 2000 with the objective of, in particular, promoting the economic and social development of the OCT more effectively and developing close economic relations between the OCT and the Union.

In the light of the above, the Council and the Commission state that for the purpose of the elaboration of the Decision to be adopted by the Council on expiry of Decision 91/482/EEC, the Council and the Commission will be guided in their deliberations by the system of rules of origin set out in point I above as far as rice and sugar are concerned, as well as the changes resulting from the procedure laid down in point II above."

Council statement re Article 2(1) concerning entry into force of the revised Decision

The Council notes that the Commission will ensure that its implementing Regulation is published the same day.

Statement by the Netherlands delegation

The Kingdom of the Netherlands can agree to the mid-term review of the Decision on the association of the overseas countries and territories. The Netherlands Antilles request that it be indicated that they cannot endorse that Decision. This does not affect the decision taken by the Kingdom.
