'The European Parliament,

- A. shocked at the recent bombing of the United States Embassy in Beirut and the resultant loss of life,
- B. convinced that an end to such acts of violence and a return to normalcy in Lebanon will only be possible following the withdrawal of all uninvited foreign forces from Lebanese territory,
- C. convinced also that the establishment of full sovereignty over the entire territory of the country by the government of Lebanon is the primary prerequisite for a return to peace,
- D. having regard to its resolutions of 17.6.1982, 15.10.1982, 16.12.1982 and 11.1.1983 (1),
 1. Condemns without reserve the brutal attack on the US Embassy in Beirut;
 2. Expresses its sympathy with the families and relatives of those who lost their lives in that attack;
 3. Reiterates its demand that all foreign troops in Lebanon present without the approval of the Lebanese government be withdrawn immediately;
 4. Recognizes with appreciation the difficult and dangerous role being played by the members of the multinational force, including troops from Community Member States, stationed in Lebanon, and calls for their presence to be maintained, if necessary, in increased number, for as long as may be required;
 5. Urges the governments of the Member States to show the utmost generosity in providing technical and material assistance to help make good war damage sustained by Lebanon;
 6. Calls on the Commission to continue to supply emergency aid to Lebanon for as long as it is needed,
 7. Instructs its President to forward this resolution to the Council and Commission, the governments of the Member States and to the Government of Lebanon.'
