The European Parliament,

- A having regard to the LINDE report (Doc. 1-816/79) on the communication from the Commission to the Council on new energy-saving guidelines for the European Community,
- B having regard to the communication and recommendation from the Commission to the council (COM/82/24 final) on investment and encouraging investment in the field of the rational use of energy,
- C having regard to the Commission proposal to the Council (Doc. 1-526/80) on the granting of financial support to demonstration projects on energy savings,
- D having regard to the ROGALLA report (PE ...),
- E whereas the objective of saving energy is an important element in an energy strategy for the Community,
- F whereas the target for 1990 set by the Council in its resolution of 9 June 1980 (OJ No C 149, p.3, Annex III) of a ratio equal to or less than 0.7% between the rate of growth in energy consumption and the rate of growth in gross domestic product, can be achieved,
- G noting that almost 50% of energy consumption in the Community is in housing and the service industries,
- Stresses that the results achieved so far in energy savings, which represent about 10% of total energy consumption in the Community, are insufficient,
- Notes that mere action to prevent waste is manifestly inadequate,
- 3. Emphasizes that the reduction of dependence on imported energy in fact requires an adequate and complete policy, at Community level, for rationalization of the use of energy sources,

- 4. Asks the Commission and Council, for these reasons, to put in hand a long-term energy savings policy,
- 5. Considers that this policy should be geared to creative investment action, including the introduction of development and pilot programmes designed to create new technologies for the saving of energy,
- 6. Considers that an option of this kind is likely to be reflected in substantial benefits in terms of employment,
- 7. Stresses, furthermore, that such investment is least likely to fuel inflation, since it will reduce production costs and alleviate pressure on prices,
- 8. Considers that, to attain this end, a public information campaign will be essential, so as to change consumption patterns and adjust them to the level of supply,
- 9. Feels there is a need to improve coordination wherever possible between action taken by the Member States, for example, by achieving some degree of harmonization of standards and national aid for energy savings,
- 10. Asks the Commission and Council to endeavour to make a long-term global policy of this kind effective and to report to Parliament on the results of their action,
- 11. Instructs its President to forward this resolution to the Commission and Council.
