By letter of 29 June 1982 the President of the Council of the European Communities requested the European Parliament to deliver an opinion on a draft regulation laying down special transitional measures for the recruitment as officials of the European Communities of 56 members of the staff of the headquarters of the European Association for Cooperation.

This proposal was referred to the Committee on Budgets as the committee responsible and to the Legal Affairs Committee for its opinion.

The Committee on Budgets submitted to the European Parliament a report which it had adopted at its meeting of 22 June 1982 by 15 votes to 1 with two abstentions.

The report was referred back to the Committee on Budgets at the July part-session.

At its meeting of 22 September 1982 the Committee on Budgets reconsidered the proposal from the Commission of the European Communities and the opinion adopted by the Legal Affairs Committee at its meeting of 12 and 13 July.

At its meeting of 22 September 1982 the Committee on Budgets also adopted the second report drawn up by Mr Silvio Lega by 11 votes to 3 with 1 abstention.

The Committee on Budgets hereby submits to the European Parliament the following amendments to the Commission proposal and motion for a resolution together with explanatory statement:

1. Proposal for a regulation laying down special transitional measures for the recruitment as officials of the European Communities of 56 members of the staff of the headquarters of the European Association for Cooperation.

Amendment No. 1

Add the following paragraph to the end of Article 3:

As provided for above in the case of seniority in step, length of service for the purposes of the Community pension scheme shall be that acquired in the service of the Association.

MOTION FOR A RESOLUTION

closing the procedure for consultation of the European Parliament on the proposal from the Commission of the European Communities to the Council for a regulation laying down special transitional measures for the recruitment as officials of the European Communities of 56 members of the staff of the headquarters of the European Association for Cooperation.

The European Parliament,

- A. having regard to the proposal from the Commission to the Council (COM(82) 285 final),
- B. having been consulted by the Council (Doc. 1-405/82),
- C. having regard to its favourable decision during the 1982 budgetary procedure concerning the establishment as officials of the European Community of the 56 members of the staff of the European Association for Cooperation,
- D. having regard to the second report of the Committee on Budgets and the opinion of the Legal Affairs Committee (Doc. 1-573/82/rev.),
- E. having regard to the result of the votes on the proposal from the Commission,
- Approves the proposal for a Council regulation subject to the above amendment.
- 2. Instructs its President to forward to the Commission and Council the proposal from the Commission as voted by Parliament and the corresponding resolution as Parliament's opinion.

EXPLANATORY STATEMENT

- During the budgetary procedure for the financial year 1982 the
 European Parliament decided that the establishment as officials of the
 European Communities of the 56 members of the staff of the European
 Association for Cooperation could be deferred no longer.
 The proposal under consideration gives effect, in the form of a
 specific legislative measure, to the decision already taken by Parliament
 through the budget¹.
- 2. For the purpose of the Community pension scheme and in order to safeguard existing pension rights, the Committee on Budgets considers that as provided for in the final paragraph of Article 3 of the proposal for a regulation in the case of seniority in step length of service should also be reckoned as from the date of engagement by the European Association for Cooperation.
- 3. Having regard to the above, the Committee on Budgets is in favour of the proposal for a regulation.

A. Expenditure

Increase the appropriations under Chapter 11 by 1,020,000 ECU. These appropriations are broken down as follows:

B. Compensation

Reduce the appropriations against Items 9800 and 9801 (EEC subsidy for the operation of the European Association for Cooperation (EAC)) by 1,498,000 ECU.

C. Revenue

Increase the appropriations under Articles 400 and 401 by 92,000 ECU and 50,000 ECU respectively.

Reduce revenue as a whole by 620,000 ECU.

REMARKS

Add the following remarks against Item 1100 (Basic salaries)
'The establishment of persons employed by the EAC as permanent staff of the Community is subject to the reform of the statute of that Association.'

The posts for the European Association for Cooperation (Headquarters) are incorporated in the Commission's establishment plan in accordance with the conditions set out in the resolution adopted by the European Parliament on 11 May 1979 (OJ No C140, 5.6.79, p. 142).

Justification

The Commission requested that employers of the European Association for Cooperation be integrated within its own complement as temporary staff.

The Council gave a favourable response to this request but preferred to await a decision on the restructuring of EAC before taking a final decision.

In its vote on the 1981 budget, Parliament established the 32 members of EAC staff seconded to the Commission as permanent staff. It seems logical therefore that the other 56 members of staff working at the Association's headquarters should also be established. This amendment also proposes that these 56 employees be given the status of permanent officials in order to facilitate any future secondment.

This regularization of the administrative position of the EMC staff must be made subject, however, to a final decision on its statute which should be taken as soon as possible.

At its meeting of 12 and 13 July 1982 the Legal Affairs Committee noted the ecision taken by Parliament at its sitting of Friday, 9 July 1982 to refer to ommittee the report (Doc. 1-408/82) by Mr LEGA on behalf of the Committee on udgets on the proposal from the Commission of the European Communities to the ouncil (Doc. 1-405/82) for a regulation laying down special transitional measures or the recruitment as officials of the European Communities of 56 members of the taff of the headquarters of the European Association for Cooperation.
