By letter of 2 October 1975 the President of the Council of the European Communities requested the European Parliament, pursuant to Articles 43 and 235 of the EEC Treaty, to deliver an opinion on the proposal from the Commission of the European Communities to the Council for a regulation amending Regulations (EEC) No. 1059/69, (EEC) No. 1060/69, (EEC) No. 2682/72, No. 120/67/EEC, (EEC) No. 3330/74, (EEC) No. 765/68 and (EEC) No. 950/68 as regards the classification in the Common Customs Tariffs of certain types of sorbitol.

At the sitting of 13 October 1975, the President of the European Parliament referred this proposal to the Committee on External Economic Affairs as the committee responsible.

On 21 October 1975 the Committee on External Economic Affairs appointed Mr Bermani rapporteur.

It considered this proposal at its meeting of 21 October 1975.

On 21 October 1975 the committee unanimously adopted the motion for a resolution and the explanatory statement.
