The President expressed the Council's gratitude to Mr Nicolas HOMMEL, Secretary-General of the Council since July 1973, who is leaving his post, on reaching retirement age, for his dedication and the great services he has rendered in carrying out the important task entrusted to him by the Council. The President of the Commission associated himself with this tribute.

FINANCIAL MECHANISM AND SUPPLEMENTARY MEASURES IN FAVOUR OF
THE UNITED KINGDOM

The Council continued its examination of the two proposals for Regulations, one amending the financial mechanism and the other establishing supplementary measures in favour of the United Kingdom.

The Council noted that there was agreement on the enacting terms of the Regulation amending the financial mechanism. The Council reached agreement on the main issues outstanding in relation to the supplementary measures in favour of the United Kingdom.

Concluding the discussion, the Council instructed the Permanent Representatives Committee to finalize the texts of these two Regulations.

MATTERS WHICH WILL COME BEFORE THE COUNCIL BEFORE THE END OF
1980

The Council had before it a note from the Presidency listing the main matters which will come before the Council meeting in a composition other than that of the General Affairs Council before the end of 1980 (so-called "la Marlia" procedure) and noted the comments made and opinions expressed by the delegations and the Commission on some of these matters, particularly those involving the 1981 draft budget and the substantive questions relating thereto and the firm undertaking to implement an overall common fisheries policy by 1 January 1981 at the latest.

INTERNATIONAL COCOA AGREEMENT

The Council instructed the Permanent Representatives Committee to finalize the Community position for the proposed UNCTAD negotiations on the basis of today's discussions.

CASSAVA IMPORTS

The Council noted that the Commission was actively continuing its talks with Thailand and other major supplier countries.

RELATIONS WITH THE ACP STATES: REQUEST FOR ACCESSION OF
THE REPUBLIC OF VANUATU TO THE SECOND ACP-EEC CONVENTION

The Council, noting that the Government of the Republic of Vanuatu had made a formal request to the ACP-EEC Council of Ministers on 24 September 1980 for accession to the second ACP-EEC Convention, stressed the importance which it attached to the accession of the Republic of Vanuatu to the second ACP-EEC Convention and expressed the hope that the accession procedure could be set in motion as rapidly as possible in accordance with Article 185 of the Convention.

PORUGAL: PRE-ACCESSION AID

Until its accession, the Community has decided to grant Portugal exceptional aid to assist with practical projects to enable the Portuguese economy to be smoothly integrated into the Community.

This exceptional pre-accession aid will amount to a total of 275 MEUA, comprising:

- 150 MEUA in investment loans financed by the European Investment Bank from its own resources, 125 MEUA of which will qualify for a 3% interest-rate subsidy to be charged to the Community budget;
- resources, to be charged to the Community budget, in the form of non-refundable aid totalling 125 MEUA for the financing of co-operation measures and projects (100 MEUA) and of interest-rate subsidies (25 MEUA).

REGIONAL FUND - QUOTA-FREE SECTION

After resolving the final outstanding question regarding the methods by which the quota-free projects will be financed by the European Regional Development Fund, the Council adopted, in the official languages of the Communities, the following five Regulations instituting specific Community measures contributing to:

- the development of certain French and Italian regions in the context of Community enlargement;
- overcoming constraints on the development of new economic activities in certain zones adversely affected by restructuring of the steel industry;
- overcoming constraints on the development of new economic activities in certain zones adversely affected by restructuring of the shipbuilding industry;
- improving security of energy supply in certain Community regions by way of improved use of new techniques for hydro-electrical power and alternative energy sources;
- the improvement of the economic and social situation of the border areas of Ireland and Northern Ireland.

RESOLUTIONS ADOPTED BY THE EUROPEAN PARLIAMENT

The Council noted that the President of the European Parliament had recently forwarded to it twenty-seven Resolutions adopted by the European Parliament at its sitting in September 1980. The President of the Council drew particular attention to the Resolutions regarding the EEC contribution to the campaign to eliminate hunger from the world, to the measures to assist the United Kingdom and to the iron and steel industry.

IRON AND STEEL PROBLEMS

The Council held a detailed exchange of views on the Commission request for assent pursuant to Article 58 of the ECSC Treaty. The Commission considered that the conditions laid down in that Article (manifest crisis) had been fulfilled.

After the discussion, the President noted that eight Member States were prepared to act on the Commission proposals for the establishment of a system of production quotas for the iron and steel industry. One delegation was unable to express an opinion on the matter since it had yet to consult its government. In these circumstances the formal decision on the assent requested by the Commission will be taken by written procedure.

As regards the social measures proposed by the Commission, the Council recognized their importance in the context of Community iron and steel policy and instructed the Permanent Representatives Committee to prepare this topic thoroughly for discussion by the Council at its next meeting.

- on a proposal from the United Kingdom Government, Mr G.H. STEVENS, as a member of the Advisory Committee of the Euratom Supply Agency to replace Mrs A.S. GITTELSON, who has resigned, for the remainder of the latter's term of office, i.e. until 28 March 1981;
- on a proposal from the German Government, Mr Georg von KLITZING and Mr Helmut SCHUG, as members of the Advisory Committee of Euratom Supply Agency to replace Mr K.A. KELTSCH and Mr H. KREWER, who have resigned, for the remainder of their term of office, i.e. until 28 March 1981;
- on a proposal from the Danish Government, Mr Jørgen ELIKOFER, Konsulent, Landsorganisationen i Danmark, as a full member of the Advisory Committee on Safety, Hygiene and Health Protection at Work, and Mrs Karen-Lisbeth SVANHOLT, Konsulent, Landsorganisationen i Danmark, as an alternate member of the Committee, to replace Mr Bendt DREWSEN, full member, who has resigned, and Mr Jørgen ELIKOFER, alternate member, who has resigned, for the remainder of their term of office, i.e. until 22 November 1981.
