Rapporteur: Mr E. LANGE

By letter of 14 May 1974 the Secretary-General of the Council of the European Communities advised that the Council had decided on 13 May 1974 to consult the European Parliament on the proposal for a directive amending Directive No. 71/307/EEC on the approximation of the laws of the Member States relating to textile names (Doc. COM(72) 1419 final Annex II).

On 21 May 1974 this proposal was referred to the Committee on Economic and Monetary Affairs as the committee responsible and the Legal Affairs Committee and the Committee on External Economic Relations were asked for their opinions.

The Committee on Economic and Monetary Affairs decided to submit the motion for a resolution to the Assembly for a vote without debate, pursuant to Rule 27 of the Rules of Procedure, and appointed Mr LANGE, chairman, rapporteur on 21 June 1974.

The committee adopted the motion for a resolution on 4 July 1974.

The opinions of the Legal Affairs Committee and the Committee on External Economic Relations are attached.

- 1. Approves the Commission's proposal;
- Instructs its President to forward this resolution and the report of its committee to the Council and Commission of the European Communities.
