## EXPLANATORY MEMORANDUM

On 21 December 1992 the Council adopted Regulation (EEC) No 3953/92 concerning the arrangements applicable to the import of products originating in the Republics of Bosnia-Herzegovina, Croatia, Slovenia and the territory of the former Yugoslav Republic of Macedonia. (1)

The Regulation maintained preferential trade arrangements in favour of the Republics equivalent to those contained in the EEC-Yugoslavia Cooperation Agreement, denounced by the Community.

Decision 92/607/ECSC of the Representatives of the Governments of the Member States meeting within the Council made similar provisions for products covered by the ECSC Treaty<sup>(1)</sup>.

Since the adoption of the Regulation and Decision, the situation in the former Yugoslav Republics, and particularly in those concerned here, has been in a constant state of flux. While the situation was returning to normal in Slovenia on the domestic front and in its international relations, both the war and the efforts to find a political solution continued in Croatia and Bosnia-Herzegovina. In the meantime, the former Yugoslav Republic of Macedonia, like the other former Yugoslav Republics, was suffering from the effects of a farreaching economic crisis.

With the conclusion of a cooperation agreement, which entered into force on 1 September 1993, the Community established contractual relations with Slovenia and put the preferential arrangements applying to that country on a contractual basis.

However, insofar as Article 16 of the EEC-Slovenia Agreement and Article 3 of the ECSC-Slovenia Agreement make reference to the autonomous measures drawn up by the Community for the implementation of these preferential arrangements, the provisions of the abovementioned Regulation and Decision need to be retained for 1994. As regards textile products, the agreement initialled on 23 July 1993 has set up tariff ceilings specific to Slovenia. Once the agreement has been concluded by the Council, administration of the ceilings will be dealt with under a special regulation.

The existing trade arrangements in favour of Bosnia-Herzegovina, Croatia and the former Yugoslav Republic of Macedonia should be maintained provided that such measures do not conflict with application of the international sanctions relating to the occupied areas of Croatia and Bosnia-Herzegovina. The tariff ceilings on textiles should

also be adapted to take account of the new situation resulting from the setting up of ceilings specific to Slovenia. (1)

Depending on developments in the political or constitutional situation in these countries or the lifting of the embargo on Serbia and Montenegro, these arrangements could be subject to reconsideration or amendment. Application of the arrangements to Bosnia-Herzegovina, in particular, should be re-examined in the case of a political settlement.

The import arrangements for Bosnia-Herzegovina, Croatia, Slovenia and the former Yugoslav Republic of Macedonia should therefore be maintained in 1994. The only amendments required are either in the drafting or concern adaptation of the tariff ceilings included in the annexes to the EEC Regulation and the ECSC Decision.

Accordingly, the Commission is putting before the Council:

- a proposal for a Council Regulation (EEC) concerning the arrangements applicable to the import into the Community of products originating in the Republics of Bosnia-Herzegovina, Croatia and Slovenia and the former Yugoslav Republic of Macedonia;
- a draft Decision of the Representatives of the Governments of the Member States, meeting within the Council, concerning the arrangements applicable to the import into the Community of products covered by the ECSC Treaty and originating in the Republics of Bosnia-Herzegovina, Croatia and Slovenia and the former Yugoslav Republic of Macedonia.

#### THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty establishing the European Community, and in particular Article 113 thereof,

Having regard to the proposal from the Commission,

Whereas Council Regulation (EEC) No 3953/92<sup>(1)</sup> established the arrangements applicable to imports into the Community of products originating in the Republics of Bosnia-Herzegovina, Croatia, Slovenia and the territory of the former Yugoslav Republic of Macedonia;

Whereas these measures should be maintained for 1994, subject to a number of drafting amendments and adaptation of the annexes,

#### HAS ADOPTED THIS REGULATION:

#### Article 1

Subject to the special provisions laid down in Articles 2 to 8, products other than those listed in Annex II to the Treaty establishing the European Economic Community and in Annex A to this Regulation, originating in the Republics of Bosnia-Herzegovina, Croatia and Slovenia and the former Yugoslav Republic of Macedonia, shall be admitted for import into the Community without quantitative restrictions or measures having equivalent effect and exempt from customs duties and charges having equivalent effect.

This Article shall be without prejudice to the provisions contained in Article 3 of Council Regulation (EEC) No 990/93 of 26 April 1993, concerning trade between the European Economic Community and the Federal Republic of Yugoslavia (Serbia and Montenegro).

The import duties, namely the customs duties and levies (variable components) applicable on import into the Community of the products listed in Annex B shall be those indicated for each product in the said Annex.

#### Article 3

- 1. The import of products listed in Annexes C I, C II, C III, and C IV shall be subject, from 1 January to 31 December, to annual ceilings, indicated for each product, above which the customs duties actually applied in respect of third countries may be reintroduced in accordance with the provisions of paragraph 2.
- 2. As soon as a ceiling set for the import of a product has been reached, the Commission may reintroduce, by means of a regulation, the levying of the customs duties referred to in paragraph 1 until the end of the calendar year.

#### Article 4

- 1. In respect of products listed in Annex D originating in the Republics referred to in this Regulation, customs duties on imports into the Community shall be reduced to the levels indicated in the said Annex for each product.
- 2. In the case of products for which annual Community tariff quotas are indicated in Annex D, these reduced levels shall be granted within the limits of the quotas.

For quantities imported in excess of the quota, the Community shall apply the customs duties actually applied in respect of third countries.

- 3. For the purposes of reduction of the customs duties in respect of certain products listed in Annex D originating in the Republics referred to in this Regulation, an annual reference quantity is set out in the said Annex.
- 4. For tobacco of the 'Prilep' type falling within CN codes ex 2401 10 60 and ex 2401 20 60 originating in and coming from the Republics concerned, paragraphs 1 and 2 shall apply within the limits of an annual Community tariff quota of 1 500 tonnes.
- 5. For plum spirit marketed under the name of 'Sljivovica' falling within CN code ex 2208 90 33, paragraphs 1 and 2 shall apply within the limits of an annual tariff quota of 5 420 hl.
- 6. For sweet cherries, clear fleshed, preserved in alcohol and intended for the manufacture of chocolate products, falling within CN code ex 2008 60 39, originating in the Republics concerned, paragraphs 1 and 2 shall apply within the limits of an annual tariff quota of 3 000 tonnes.

- 1. For sour cherries falling within CN codes 0809 20 20, 0809 20 60, ex 0811 90 10, ex 0811 90 30, 0811 90 75, 0812 10 00, 2008 60 51, 2008 60 61, 2008 60 71 or 2008 60 91 originating in the Republics concerned, the customs duties payable shall be those referred to in Annex D.
- 2. Paragraph 1 shall apply within the limits of ceilings of 3 000 tonnes for sour cherries falling within CN codes 0809 20 20 and 0809 20 60 and 19 900 tonnes for sour cherries falling within the other CN codes referred to therein. Where these ceilings are exceeded, the issuing of the import certificates provided for in respect of the products concerned may be suspended.

Paragraph 1 shall apply to sour cherries falling within CN codes ex 0811 90 10, ex 0811 90 30, 0811 90 75, 2008 60 51, 2008 60 61, 2008 60 71 or 2008 60 91 on condition that the minimum import price set by the Community is applied. Where the minimum price is not applied, a countervailing charge shall be payable.

#### Article 6

- 1. For wines of fresh grapes falling within CN codes ex 2204 21 or ex 2204 29 originating in the Republics concerned, import duties shall be reduced to the levels set out in Annex D. This provision shall apply within the limit of an annual Community tariff quota of 545 000 hl. For quantities imported in excess of the quota, the Community shall apply the duty laid down in the common customs tariff.
- 2. Paragraph 1 shall apply on condition that the price on import into the Community of the wines originating in the Republics concerned, plus the customs duties actually collected, is at all times at least equal to the Community reference prices.

## Article 7

The following provisions shall apply to 'baby-beef' products defined in Annex E:

1. Within the limits of an initial annual Community quota of 25 000 tonnes, the amount of levy collected on imports into the Community shall be equivalent to 20% of the basic levy. This provision shall apply on condition that the free-at-frontier offer price, plus customs duty and the reduced levy, is equal to or higher than the Community intervention price for the category AU 3 plus 5%.

- 2. Within the limits of a second annual Community quota of 25 400 tonnes, to be used after the quota referred to in paragraph 1 is used up, the amount of levy collected on imports into the Community shall be equivalent to 50% of the basic levy. This provision shall apply on condition that the free-at-frontier offer price, plus customs duty and the reduced levy, is equal to or higher than the price resulting from application of the standard levy.
- 3. To help stabilize the Community's internal market, the Commission shall ensure that each Republic concerned maintains an appropriate delivery rate and shall adopt any measures required to ensure the orderly growth of its exports to the Community, in particular through effective controls on each consignment by means of a certificate stating that the goods originate in and come from the Republic concerned and correspond exactly to the definition in Annex E. The text of this certificate shall be drawn up by the Community.
- 4. Where the Community market price is less than 98% of the guide price, paragraphs 1 and 2 shall apply within the limit of a volume of 4 200 tonnes per month. Where, during a certain month, this volume has not been entirely used up, the remaining quantity may be carried over only to the following month.
- 5. The Commission shall ensure that each Republic concerned transmits any relevant information concerning export prices together with the quantities and presentation of the products exported (livestock, carcases or quarters) to the Community authorities.

The Kingdom of Spain and the Portuguese Republic shall apply, mutatis mutandis, customs duties calculated in accordance with Regulation (EEC) No 4150/87.(1)

# Article 9

The ceilings, reference quantities and quotas provided for in this Regulation shall apply as a whole to all the Republics to which this Regulation refers, except for the ceilings in Annex C II, which apply solely to the Republics of Bosnia-Herzegovina, Croatia and the former Yugoslav Republic of Macedonia.

The detailed rules for implementing the agricultural provisions referred to in this Regulation shall be determined by the Commission.

The rules of origin shall be adopted in accordance with the procedure laid down in Article 14 of Council Regulation (EEC) No 802/68 of 27 June 1968 on the common definition of the concept of the origin of goods.(1)

#### Article 11

This Regulation shall enter into force on the day following its publication in the Official Journal of the European Communities.

It shall be applicable from 1 January to 31 December 1994.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

Draft Decision of the Representatives of the Governments of the Member States meeting within the Council of ...... 1993 concerning the arrangements applicable to imports into the Community of products covered by the ECSC Treaty originating in the Republics of Bosnia-Herzegovina, Croatia and Slovenia and the former Yugoslav Republic of Macedonia

THE REPRESENTATIVES OF THE GOVERNMENTS OF THE MEMBER STATES MEETING WITHIN THE COUNCIL,

Having regard to the Treaty establishing the European Coal and Steel Community,

Whereas Decision No 92/607/ECSC<sup>(1)</sup> of the Representatives of the Member States meeting within the Council of 21 December 1993 established the arrangements applicable to imports into the Community of products covered by the ECSC Treaty originating in the Republics of Bosnia-Herzegovina, Croatia and Slovenia and the territory of the former Yugoslav Republic of Macedonia;

Whereas these arrangements should be maintained for 1994, subject to a number of draftingamendments and adaptation of the annexes,

In agreement with the Commission,

#### HAVE DECIDED AS FOLLOWS:

#### Article 1

1. Subject to the special provisions laid down in paragraphs 2 and 4, products originating in the Republics of Bosnia-Herzegovina, Croatia and Slovenia and the former Yugoslav Republic of Macedonia shall be admitted for import into the Community without quantitative restrictions or measures having equivalent effect and exempt from customs duties and charges having equivalent effect.

This paragraph shall be without prejudice to the provisions contained in Article 3 of Decision No 93/235/ECSC<sup>(2)</sup> of the Representatives of the Governments of the Member States, meeting within the Council of 26 April 1993, concerning trade between the European Coal and Steel Community and the Federal Republic of Yugoslavia (Serbia and Montenegro).

- 2. The import of goods referred to in the Annex shall be subject to a system of annual ceilings above which the customs duties actually applied in respect of third countries may be reintroduced in accordance with the provisions of paragraph 3. The ceilings established for 1993 are indicated for each of them. Such ceilings shall apply as a whole to all the Republics to which this Decision refers.
- 3. As soon as a ceiling set for the import of a product has been reached, the customs duties actually applicable to third countries may again be levied on imports of the product in question until the end of the calendar year.
- 4. The Kingdom of Spain and the Portuguese Republic shall apply, mutatis mutandis, customs duties calculated in accordance with Decision 87/603/ECSC of the Representatives of the Governments of the Member States, meeting within the Council, and of the Commission of 21 December 1987.(1)

#### Article 2

The provisions determining the rules of origin laid down in Regulation (EEC) No  $343/92^{(2)}$  shall apply to this Decision.

#### Article 3

Where the offers made by economic operators in the Republics concerned are likely to cause injury to the operation of the common market and where this injury may be ascribed to a difference as regards prices in the conditions of competition, the Community may adopt such safeguard measures as it considers necessary to avoid or put an end to the injury to the operation of the common market; in particular it may withdraw tariff concessions.

#### Article 4

This Decision shall enter into force on the day following its publication in the Official Journal of the European Communities.

It shall be applicable from 1 January to 31 December 1994.
