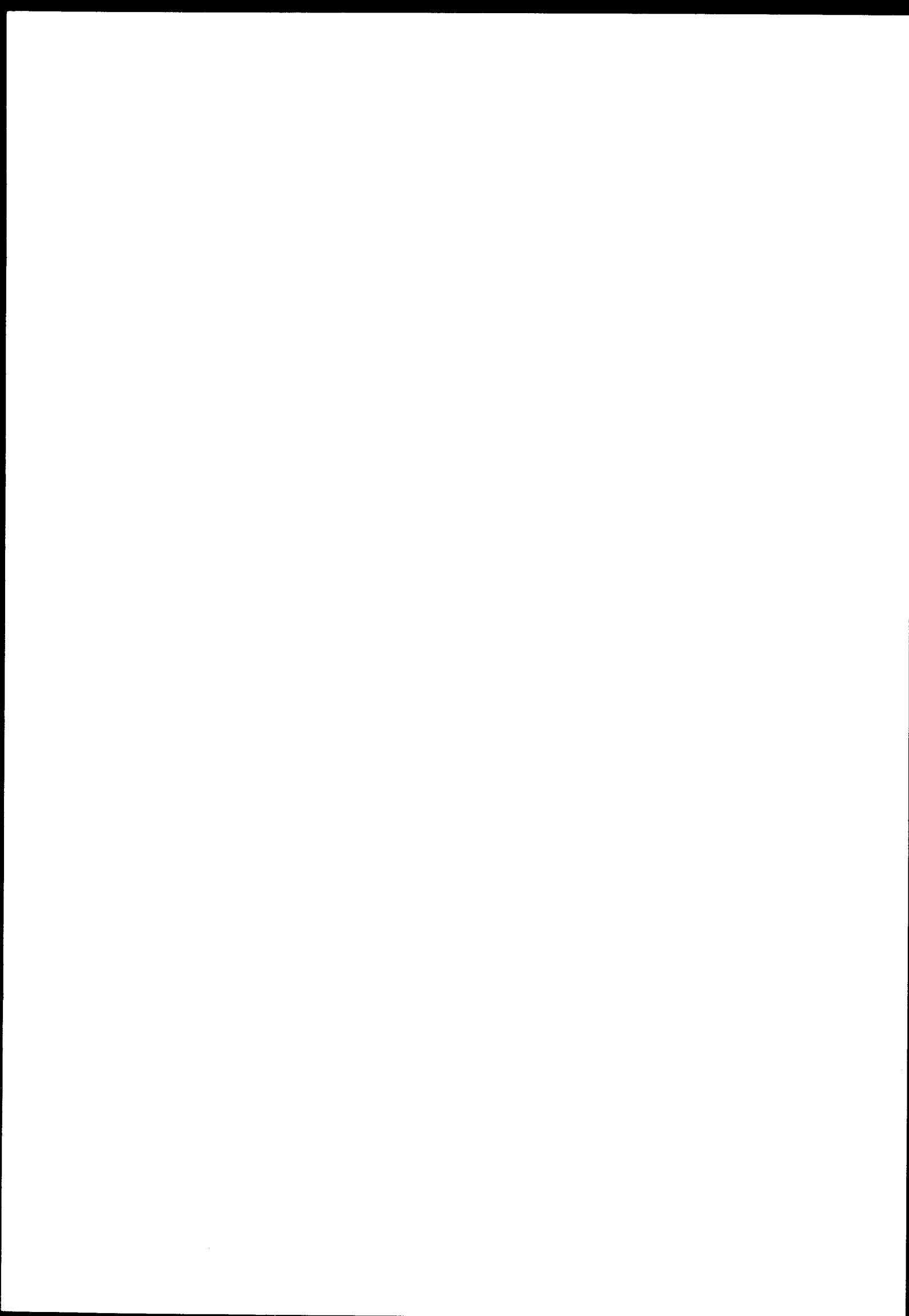

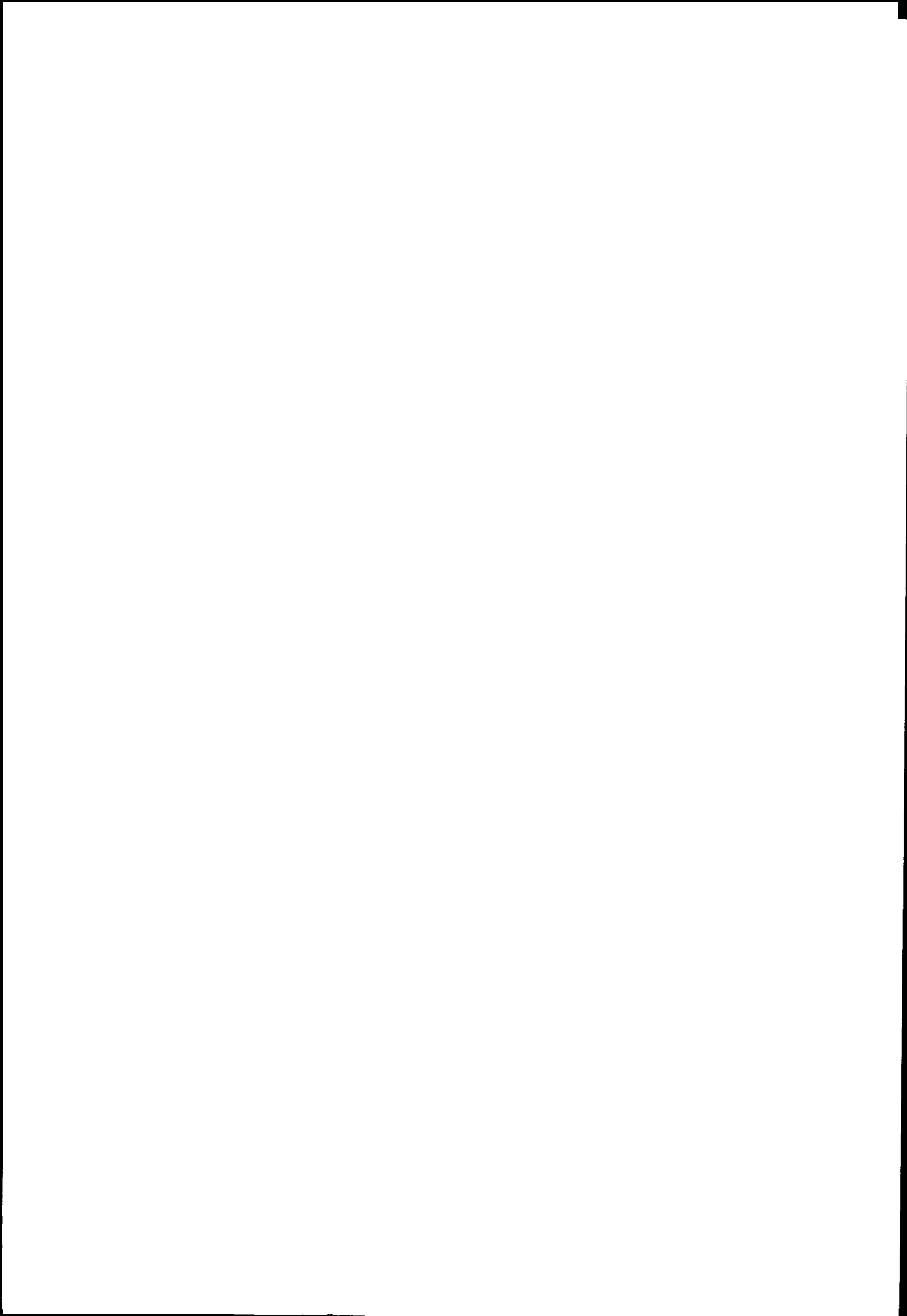

EXPLICATORY NOTE

Article 4 of Council Regulation (EEC) no 2753/78 provides that producer organisations shall submit an aid application each month for all members who completed their production of oil in the course of the previous month.

The large numbers of members and the complexity of effective control by the said organisations makes it necessary to adapt the provisions set out in this Article.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing establishing the European Economic
Community,

Having regard to Council Regulation N° 136/66/EEC of 22 September 1966
on the establishment of a common organization of the market in oils and fats⁽¹⁾,
as last amended by Regulation (EEC) N° 590/79⁽²⁾, and in particular Articles
16(6) and 19(3) thereof,

Having regard to the proposal from the Commission,

Whereas Article 4 of Council Regulation (EEC) N° 2753/78⁽³⁾
provides that a producer organization shall submit a single aid application
each month for all members who completed their production of oil in the course
of the previous month; whereas experience has shown that, owing to the large
number of members of each organization and the complexity of the
controls to be carried out, some organizations are unable to put forward the
aid application referred to above each month; whereas, in order to remedy
these difficulties, the said Article 4 should be amended,

HAS ADOPTED THIS REGULATION :

Article 1

The first sentence of the third paragraph of Article 4 of Regulation (EEC) No 2753/78 is amended to read as follows:

"Where growers are members of a producer organization, that organization shall, each month, submit a single aid application for all members who have completed their production of oil and in respect of whom the checks referred to in Article 5 have been completed."

Article 2

This Regulation shall enter into force on the day following its publication in the Official Journal of the European Communities. It shall apply with effect from 1 January 1979.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
