# Proposal for a COUNCIL REGULATION (EEC) ·

amending Regulations (EEC) No 1408/71 and (EEC) No 574/75 EXPARTS eUNDFlication of social security schemes to employed persons and their families moving within the Community

(submitted to the Council by the Commission)

#### EXPLANATORY MEMORANDUM

The purpose of this Proposal for a Council regulation is to formulate the adaptations to the Acts of the Council concerning social security for migrant workers that are made necessary by the accession of Greece in so far as they have not yet been specified in Annex I to the Act concerning the conditions of accession.

Since the said Act was signed, two Council Regulations 1 have been adopted.

Moreover, paragraphs 2 and 3 of Chapter V of Annex II to the said Act provide that Annex II to Regulation No 1408/71 must be amended in so far as the conclusion of an Agreement between the Member States on the maintenance of certain provisions of bilateral Agreements so require.

### Article 1

The competent authorities of Germany and Greece have agreed to maintain in force certain provisions of the Convention on unemployment insurance of 3 May 1961 and a Protocol concluded on 13 June 1980 to implement these provisions.

These provisions are more favourable than the corresponding ones of Regulation No 1408/71.

Pursuant to Annex II, Chapter V, paragraphs 2 and 3 of the Act of Accession, Annex II to Regulation No 1408/71 must therefore be amended.

### Article 2

Article 4(3) of Regulation No 1517/79 has added a new Article 12a to Regulation No 574/72.

The competent authorities of each Member State must designate an institution for the implementation of the provisions of this Article.

In accordance with Article 4(10) of Regulation No 574/72, these institutions must be listed in Annex 10 to the said Regulation.

### Article 3

Pursuant to Article 146 of the Act of Accession, the Regulation must enter into force as from accession.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to the Act of Accession of Greece, and in particular Article 146(2) thereof;

Having regard to the proposal from the Commission;

whereas the Council adopted on 14 June 1971 Regulation (EEC) No 1408/81 on the application of social security schemes to employed persons and their families moving within the Community<sup>1</sup>, and on 21 March 1972 Regulation (EEC) No 574/72<sup>2</sup> laying down the procedure for implementing Regulation (EEC) No 1408/71, both Regulations being tast amended by Regulation (EEC) No 1517/79<sup>3</sup>,

Whereas, pursuant to Article 22 of the said Act, certain adaptations made necessary by accession and in conformity with the guidelines set out in Annex II to the said Act must be made to Regulations (EEC) No 1408/71 and (EEC) No 574/72,

HAS ADOPTED THE FOLLOWING REGULATION:

### <u>Article 1</u>

In Section A of Annex II to Regulation (EEC) No 1408/71, the entry

- "19. Germany-Greece" is horeby replaced by the following:
- "19. Germany-Greece
- (a) Article 8(1), (2)(b) and (3), Articles 9 to 11, and Chapters I and IV in so far as they concern the abovementioned Articles, of the Convention on employment insurance of 31 May 1961.
- (b) The Protocol of 13 June 1980."

### Artiole 2

In Annex 10 to Regulation (EEC) No 574/72, the entry "E. Greece" is hereby amended as follows:

Paragraph 2 is replaced by the following:

"2. For the purposes of Article 14(1)(c)(i) of the Regulation and Article 12a(1) of the Implementing Regulation:

IAPYMA KOINGNIKAN A ZMANINEAN (IKA) A9HNA
Social Insurance Institute (IKA), Athens."

Paragraphs 2, 3, 4, 5, 6 and 7 are renumbered 3, 4, 5, 6, 7 and 8 respectively.

### Article 3

This Regulation shall enter into force on 1 January 1981.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
