Explanatory memorandum

The Commission sent a proposal for a regulation relating to Community intervention measures for industrial restructuring and conversion operations to the Council on 31 October 1978 ¹. Under the terms of this Regulation the Community must be given the opportunity to grant appropriate financial aids to undertakings' investment programmes, thus facilitating the structural changes necessary to overcome the crisis in certain sectors.

The European Parliament delivered its Opinion on this proposal at the time of its session of 26 April 1979. The Commission closely examined the remarks made in this Opinion and decided to give effect to the proposed amendment to the second paragraph of Article 1.

This amendment aims at introducing a requirement for the European Parliament's Opinion to be obtained before the Council can decide on those sectors to which aids may be granted.

The Commission takes the view that this amendment must be extended to include the Economic and Social Committee in the consultation process.

This amendment, introduced into the abovementioned proposal for a Regulation, also requires an amendment to the two proposals for Decisions recently sent to the Council² to enable the shipbuilding industry and the textile industrie, particularly the man-made fibres industry sectors to benefit from the financial aids provided for by the Regulation.

1) Amendment to the proposal for a Regulation on Community aid for industrial restructuring and conversion operations 1.

The second paragraph of the first Article of the proposal for a Regulation is amended as follows:

- the Council, acting on a proposal from the Commission and on the Opinion of the European Parliament and of the Economic and Social Committee, shall decide, by a qualified majority on those sectors to which aid may be granted.
