Trade balances

II. TRADE IN GENERAL (INTRA-COMMUNITY TRADE AND TRADE WITH THE REST OF THE WORLD)

1. The relative scale of trade in 1974

In 1974, the Community's imports of 234 400 million u.a. represented 25.5% of its gross domestic product (GDP) as against 171 000 million u.a. (20.5%) in 1973 and its exports of 220 000 million u.a. represented 24% as against 167 900 million u.a. or 20.1% in 1973.

From 1973 to 1974 in the Community, imports per inhabitant increased from 669 u.a. to 909 u.a. and exports from 654 u.a. to 853 u.a.; in the United States imports per inhabitant increased from 263 u.a. to 404 u.a. and exports from 271 u.a. to 367 u.a.

In 1974, the Nine ran up an overall trade balance deficit of 14 402 million u.a. (3 767 million u.a. in 1973). Of the Member States, only the Federal Republic of Germany achieved an export surplus and it was also one of the few Western countries to increase its export surplus in 1974 (import-export "Cover" rate in 1924 = 129% and in 1973 = 123%).

2. Relative shares in intra-Community trade in 1974

In 1974, Germany accounted for 26% of intra-Community trade as against 27% in 1973; it was followed, in descending order, by:

France: 18% (unchanged)
Netherlands: 16% (15%)
BLEU: 14% (unchanged)
Italy: 11% (unchanged)
United Kingdom: 10% (unchanged)
Denmark: 3% (unchanged)
Ireland: 2% (unchanged)

3. The intra-Community trade surpluses and deficits in 1974

In 1974, as in 1973, the Benelux countries and Germany achieved surpluses on intra-Community exports; Germany and the Netherlands recorded a rise in the import/export cover rate of 9 and 5 points respectively, while the BLEU lost 4 points. For the same period, France kept its intra-Community merchandise exports and imports virtually in balance (97%). As for the other Member States, the United Kingdom reduced its deficit by 1 point (7%), Italy increased hers by 3 points (7%), Ireland by 5 points (76%) and Denmark by 6 points (74%).

Of the Nine, France had the largest relative increase in its deficit - 18 points. It is followed, in descending order, by the United Kingdom (11 points), BLEU (10 points), Ireland (10 points), Italy (7 points) and the Netherlands (1 point). However, Denmark reduced the deficit on its extra-Community balance by one point and Germany increased its export surplus by one point.

6. Geographical analysis of trade by class of product

In 1974, 46% of total Community imports came from the industrialized countries, 47% from the developing countries and 7% from the State-trading countries.

58% of Community exports went to the industrialized countries, 31% to the developing countries and 10% to the State-trading countries.

As is shown in Table 15, the pattern is by no means the same for each class of product.
