I. THE COMMUNITY AND WORLD TRADE IN 1975*

A.1 World trade including intra-Community trade

There are statistical difficulties in presenting the development of world trade. Given an equal volume of goods, its value differs according to whether it is expressed in current US dollars (the value of which has not been constant since 1971) or in EUR, whose value is still 0.8886708 grams of fine gold (equivalent to the \$ before 1971). The conversion of national currencies into EUR is made, for currencies within the Community exchange rate system, on the basis of central rates; for other currencies, conversion is on the basis of market rates in relation to the currencies within the snake. Currency exchange rates are calculated and published by the SOEC.

The average annual rates are:

1974 1 EUR = \$1.25

1975 1 EUR = \$1.32

Tables 4 and 5 demonstrate a certain decrease in the share of petroleum-producing countries in world exports in 1975 as compared with 1974.

II. COMMUNITY TRADE IN GENERAL IN 1975 (INTRA-COMMUNITY TRADE AND TRADE WITH THE REST OF THE WORLD)

1. The relative scale of general trade in 1975

In 1975, the Community's imports of 227 400 million EUR represented 22.3% of its gross domestic product (GDP) (as against 234 400 million EUR and 25.5% in 1974) and its exports of 224 600 million EUR represented 22.1% of GDP (220 000 million EUR and 24% in 1974).

From 1974 to 1975 in the Community, imports per capita decreased by 29 EUR (880 EUR in 1975 as against 909 EUR in 1974) and exports increased by 16 EUR (869 EUR in 1975 as against 853 EUR in 1974). Developments in the United States over the same period were similar to those in the Community (see Table 5).

In 1975, the Community's trade balance improved appreciably and is now virtually in balance (a deficit of 2 866 million EUR as against a deficit of 14 402 million EUR in 1974). The rate of cover of exports by imports is 99% as against 94% in 1974. This overall balance, however, masks imbalances at Member State level. Only Germany has achieved a considerable export surplus and the Netherlands a balanced situation, while the others have a trade deficit.

In 1975, general imports comprised 43% (44% in 1974) of primary products (agricultural products, raw materials + semi-manufactures, energy) and 55% (55% in 1974) of manufactures; exports comprised 20% (20% in 1974) of primary products and 79% (79% in 1974) of manufactures (see Annexes 4 and 5).

2. Relative shares in intra-Community trade in 1975

In 1975, Germany accounted for 26% of intra-Community trade (26% in 1974); it was followed, in descending order, by:

France: 18% (unchanged)
Netherlands: 15% (16%)
BLEU: 14% (unchanged)
Italy: 11% (unchanged)
United Kingdom: 11% (10%)
Denmark: 3% (unchanged)
Ireland: 2% (unchanged)

3. Intra-Community trade surpluses and deficits in 1975

In 1975, the Netherlands and Germany achieved surpluses on intra-Community exports, but only the Netherlands recorded a rise in the surplus with the import/export ratio going up by 3 points (125% as against 122% in 1974). In Germany the import/export ratio went down by 14 points (106% as against 120% in 1974), while in Belgium/Luxembourg it was down 2 points (99% as against 101% in 1974). In 1975, France kept its exports and imports in balance and Ireland, by considerably reducing its trade deficit, achieved a balance (97% as against 76% in 1974). As for Italy (95% as against 79% in 1974), Denmark (83% as against 74% in 1974) and the United Kingdom (82% as against 79% in 1974), in spite of the improvement in the import/export ratio, these countries still had intra-Community trade deficits.




Structure of the Community's trade with the rest of the world in 1975 -
