PROPOSAL FOR A REGULATION (EEC) OF THE COUNCIL

extending the term of validity of Regulation (EEC) No 1267/69
laying down special provisions applicable to
imports into the Community from Greece
of goods coming under Regulation (EEC) No 1059/69

(submitted to the Council by the Commission)

EXPLANATORY MEMORANDUM

The special provisions adopted pursuant to Article 12 of Regulation (EEC) No 1059/69 in respect of goods covered by this Regulation which are imported from Greece into the Member States, are at present the subject of Regulation (EEC) No 1267/69, as last amended by Regulation (EEC) No 1687/74.

These provisions, which merely reproduce those adopted pursuant to Article 17 (a) of Regulation No 160/66/EEC, are due to expire on 30 June 1975. Under these provisions:

- (i) Greek goods are exempt from the fixed component levied on imports from third countries;
- (ii) Ravioli, macaroni, spaghetti and similar products, turkish delight, halva and certain food preparations falling within Heading number 21.07 of the Common Customs Tariff qualify for a reduction of 40% of the amount of the variable component laid down for these same goods imported from third countries.

It is recommended that the application of the provisions in force should be extended.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to Council Regulation (EEC) No 1059/69 (1) of 28 May 1969 laying down the trade arrangements applicable to certain goods resulting from the processing of agricultural products, as last amended by Regulation (EEC) No 1491/73 (2), and in particular Article 12 thereof;

Having regard to the proposal from the Commission;

Whereas the Council, by Regulation (EEC) No 1267/69 (3), as last amended by Regulation (EEC) No 1687/74 (4), laid down the special provisions applicable to imports into the Community from Greece of goods coming under Regulation (EEC) No 1059/69; whereas these provisional arrangements are due to expire on 30 June 1975;

Whereas the term of validity of the Regulation in question should be extended,

HAS ADOPTED THIS REGULATION:

Article 1

In Article 3 (2) of Regulation (EEC) No 1267/69, the date '30 June 1975' is replaced by '30 June 1976'.

Article 2

This Regulation shall enter into force on 1 July 1975.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
