EXPLANATORY MEMORANDUM

- 1. In its Decision of 5 April 1976 the Council approved the Community proceeding to a duty reduction for some tropical products within the multilateral GATT negotiations.
- 2. This reduction has been put into force as a temporary duty suspension and will be inserted in the CCT after the results of the tariff negotiations of the Tokyo-Round (see Regulations (EEC) N°s 2858/76 and 2745/77 temporarily suspending the autonomous Common Customs Tariff duties on a number of tropical products = 0J No L 329 of 27.11.1976, page 9 and N° L 318 of 13.12.1977, p. 1).
- 3. As this duty suspension expires on 31 December 1978 and the negotiations are not yet terminated the tariff measure in question should be prolonged until 31 December 1979.

4. This is the objective of the following regulation.
