# GRANTS OF £ 6 072 302 FOR AGRICULTURAL AND FISHERIES INVESTMENT

## First FEOGA allocation for 1986

The European Commission has announced grants totalling £ 6 072 302 for 47 projects designed to improve the processing of agricultural and fishery products. The grants are additional to national grant aid.

Regulation 355/77 provides EEC farm fund money to finance improvements in certain agricultural sectors through programmes agreed between the Government and the Commission. Processing and marketing projects in the fisheries sector are also supported under this regulation.

The project marked with an asterisk (\*) is supported under Regulation 1943/81 designed to improve the processing and marketing conditions in the cattlefeed sector in Northern Ireland.
