GRANTS OF £5 247 081 FOR AGRICULTURAL AND FISHERIES INVESTMENT

Second FEOGA allocation for 1983

The European Commission has announced grants totalling £4 908 228 for the processing and marketing of agricultural and fishery products, and £338 853 for modernisation of the Northern Ireland animal feeds sector. The grants are additional to national grant aid.

Regulation 355/77 provides EEC farm fund money to finance improvements in certain agricultural sectors through programmes agreed between the Government and the Commission. Processing and marketing projects in the fisheries sector also qualify for assistance.

The aid goes to the following sectors:
