EXPLANATORY MEMORANDUM

The present draft is intended:

1. to adjust the 1978 catch quotas for the Faeroe Islands laid down in Annex I of Regulation (EEC) No. 1848/78, modified by Regulation (EEC) No. 2084/78, by the addition of a quota for Greenland Halibut in ICNAF zones 0 + 1.

The Canadian authorities have recently allocated a Greenland Halibut quota to the Faeroe Islands. In conformity with the management arrangements agreed between the Community and Canada for certain joint stocks occurring in the Davis Strait and Baffin Bay the Community must authorize Faeroese vessels to fish part of this quota in the waters falling under the fisheries jurisdiction of the Community.

2. to delay by one month the date of entry into force of the obligation for Faeroese vessels to have a licence on board as foreseen in Article 3 paragraph 1 of the said Regulation, taking into account that the consultations foreseen in paragraph 2 of this Article have not yet taken place.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Article 103 thereof,

Having regard to the proposal from the Commission,

Whereas by Regulation (EEC) No. 1848/78 of 25 July 1978 (1), as amended by Regulation (EEC) No. 2084/78 (2), the Council laid down certain measures for the conservation and management of fishery resources applicable to vessels registered in the Faeroe Islands;

Whereas, according to the management arrangements agreed between the Community and Canada as regards certain joint stocks located in Davies Strait and Baffins Bay, fishing for Greenland Halibut by either party should be permitted throughout the joint management zone;

Whereas the recent allocation by the Canadian authorities of a quota of Greenland Halibut to the Faeroe Islands may therefore lead to the fishing of a part of this quota in waters falling under the fisheries jurisdiction of the Community;

Whereas due account should be taken of this in the said Regulation (EEC) No.1848/78;

Whereas, since the consultations referred to in paragraph 2 of Article 3 of Regulation (EEC) No. 1848/78 have not yet taken place, the entry into force of paragraph 1 of the said Article should be postponed for one month;

Whereas these measures must be taken without delay, and it is therefore necessary to adopt them on an interim basis, under Article 103 of the Treaty, subject to their being included at a later date in the common agricultural policy.

Article 1

1. Article 3(1) is amended to read as follows:

"1. From 1 November 1978, fishing within ICES divisions IV,
VI, VII and VIII and ICNAF zones 0 + 1 under the quotas established
in Article 1 shall be subject to the granting of a licence issued
by the Commission on behalf of the Community and to the observance
of the conditions set out in the licence."

Regulation (EEC) No 1848/78 is amended as follows:

2. Annex I is replaced by the Annex to this Regulation.

Article 2

This Regulation shall enter into force on the day of its publication in the Official Journal of the European Communities.

It shall apply until 31 December 1978.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
