EXPLANATORY NOTE

In Article 8 of Protocol No. 3 to each of the EEC-EFTA Agreements there are three limits expressed in ECU which relate to the form of documentation required to establish a right to obtain preference. These limits have no economic effects.

The same Article 8 provides for the value of ECU used to be frozen for two years at a time, based on the value of the ECU at a fixed date. Every two years the base date is automatically changed.

This automatic change of base date has the result that the currency equivalents to the limits expressed in ECU are reduced in those Member States or EFTA countries with stronger currencies. Even if this is compensated for, by altering the ECU value of the limits upwards so that the limits as expressed in the currency of any country involved is never decreased, this still means that over time the real value of the limits tends to decrease. This decrease in the real value of the limits means that the administrative savings involved in using simplified documentation of origin status becomes relatively less as time goes on.

The proposed draft Joint Committee Decision is intended to raise the limits of 2,750 ECU, 550 ECU and 190 ECU to 3,400 ECU, 680 ECU and 240 ECU respectively to take account of these factors.

For the sake of completeness and clarity a draft of a Council Regulation to apply the Joint Committee Decisions when adopted are included. .

THE JOINT COMMITTEE,

Having regard to the Agreement between the European Economic Community and (A) signed in Brussels on (B),

Having regard to Protocol 3 concerning the definition of the concept of 'originating products' and methods of administrative cooperation, and in particular Article 28 thereof,

Whereas the equivalents of the amounts in ECU in some national currencies on 1 October 1982 were lower than their equivalents on 1 October 1980; whereas this fact, as a result of the automatic change of base date provided for in Decision No. 1/78 of the Joint Committee would lead, on the conversion into the national currencies concerned, to a diminution of the effective limits for simplified documentary requirements; whereas in order to avoid this, it is necessary to raise the limits expressed in ECU,

HAS DECIDED AS FOLLOWS :

Article 1

Article 8 of Protocol 3 as last amended is hereby further amended by replacing in :

- paragraph 1(b) "2750 ECU" by "3400 ECU",
- paragraph 2, "190 ECU" by "240 ECU" and "550 ECU" by "680 ECU".

Article 2

This Decision shall enter into force on 1 May 1983.

Article 1
