Proposal for a COUNCIL REGULATION (EEC)

establishing ceilings and Community supervision for imports of certain goods originating in Yugoslavia (1983)

COM(82) 703 final

EXPLANATORY MEMORANDUM.

The proposal for the Regulation joined hereto has as its objective

- to establish ceilings to be applied in 1983 for imports of certain goods originating in Yugoslavia;
- to attribute to the Commission the competence to re-establish customs duties under certain conditions;
- to establish a system of surveillance relating to imports of goods which are or are not subject to ceilings.
- 1. The/Agreement concluded by the EEC with Yugoslavia provides for dutyfree import into the Community of nearly all goods falling under Chapters No. 25 to 99 of the Common Customs Tariff and originating in Yugoslavia. As an exception to this provision Protocol No. 1 stipulates that the imports of some of these goods shall be subject to ceilings above which the customs duties applicable to non-member countries may be reintroduced until the end of the calendar year. (4)
- 2. Implementation of these two provisions:
- (a) annual ceilings, and
- (b) reintroduction of customs duties;

implies the adoption of precise common rules to be applied uniformly by all Member States. These requirements may be met by the establishment of a Community system of supervision of actual imports from the partner country. To this end, the Member States should take appropriate measures to permit the rapid collection of statistical returns at Community level. In this connection it is necessary to take into account only imports of the products in question as and when they are entered with Customs authorities for free circulation and accompanied by a movement certificate conforming to the rules contained in the Agreement referred to under 1 above.

These returns should be drawn up by each Member State at the end of every month and forwarded by the fifteenth day of the following month to the Commission so as to enable the latter to communicate to all the Member States the overall, good-by-good returns for the imports in question in the preceding month. The system of supervision will require of the responsible departments of the Member States and the Commission diligence and close cooperation.

3. The following system would be adopted for setting in train machinery to reintroduce duties: if one of the overall monthly returns drawn up by the Commission revealed that 75% of the ceiling fixed for a given good had been reached, consultations could be held, for example in the Working Party on Economic Tariff Problems, either at the request of a Member State or upon the Commission's initiative. The aim of these consultations would be to examine, case by case, the reintroduction or not of the levying of customs duties applicable to non-member countries once the ceiling is actually reached.

Monthly returns would still be made in respect of imports of the product in question or, if it is requested by the Commission by telex at intervals of ten days. The set term for the transmission of this last mentioned information is five days. In these conditions, the Commission would be able to take, within the shortest possible time, measures leading to the reintroduction, by regulation, of customs duties in respect of the partner country until the end of the calendar year. In the above hypothesis, the reintroduction of the levying of customs duties on the good under consideration would, naturally, be effected within the time-limit fixed by the regulation.

4. As far as application of the rule on ceilings and reintroduction of duties is concerned, the proposal makes provisions for conferring powers of the Council upon the Commission.

The proposed regulation does no more than outline how these powers are to be exercised so that, in consultation with the Member States, the machinery to be set in train may be adapted flexibly and rapidly. Furthermore, it is likewise with a view to maximum efficiency and rapidity that the proposal lays down that it would be up to the Commission to reintroduce, in respect of the partner country, the levying of the duties applicable to non-member countries.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European-Economic Community, and in particular Article 113 thereof,

Having regard to the proposal from the Commission,

Cooperation

Whereas a / Agreement between the European Economic Community and the Socialist Federal Republic of Yugoslavia (1) was concluded on ----;

Whereas under Article 1 of Protocol 1 annexed to that Agreement imports of the goods therein set out are limited to annual ceilings above which the customs duties applicable to third countries may be reintroduced;

whereas this Protocol was modified by Council Regulation (EEC) N° 287/82 of 3 February 19 establishing the arrangements applicable to imports of products originating in Yugoslavia to take account of the accession of the Hellenic Republic to the Community (2), and by the Supplementary Protocol to the Co-operation Agreement between the European Economic Community and the Socialist Federal Republic of Yugoslavia concerning trade in textile products (3), hereafter referred to as the Supplementary Protocol; whereas, therefore, the ceilings to be applied in 1983 must be established; whereas in this situation it is necessary that the Commission be regularly informed of the trend of the imports of the goods in question and, in consequence, it is necessary to subject these imports to

Whereas this objective may be achieved by means of an administrative procedure based on setting off imports of the products in question against the ceilings at Community level, as and when these products are entered with customs authorities for free circulation; whereas this administrative procedure must make provision for the reintroduction of customs tariff duties as soon as the ceilings have been reached at Community level;

Whereas this administrative procedure requires close and particularly rapid cooperation between the Member States and the Commission; whereas the latter must, in particular, be able to follow the progress of amounts set off against the ceilings and keep the Member States informed; whereas this cooperation must be all the closer

since the Commission must be able to take adequate measures to reintroduce customs tariff duties whenever one of the ceilings has been reached;

Whereas the trend of imports should be followed for certain goods; whereas it is therefore desirable that imports of such goods should be subject to supervision,

HAS ADOPTED THIS REGULATION.

Article 1

1. From 1 January to 31 December 1983 imports of certain goods originating in Yugoslavia and listed in Annexes I, II, III and IV shall be subject to ceilings and to Community supervision.

The description of the goods referred to in the preceding subparagraphs, their tariff headings and statistical numbers and the levels of the indicative ceilings or "sub-ceilings are given in the abovementioned Annexes."

The sub-ceilings established for certain products in Annex II not covered by Article 4 of the Supplementary Protocol are indicated in column 5 of that Annex.

2. Amounts shall be set off against the ceilings or sub-ceilings as and when the goods are entered with customs authorities for free circulation and accompanied by a movement certificate conforming to the rules contained in Protocol 2 to the Agreement.

With regard to the ceilings established for categories 4, 5, 6, 7, 8, 12, 15 B, 16, 18, 24/25 and 73 of Annex II, re-imported products which have undergone one or several of the processes indicated in Article 4 of the Supplementary Protocol may be charged against the respective ceilings only if the movement certificate is endorsed by the competent Yugoslav authorities to the effect that the products in question have undergone such a treatment.

Goods shall be set off against the ceiling or sub-ceilings only if the movement certificate has been submitted before the date on which customs duties are reimposed.

The reaching of a ceiling shall be determined at
Community level on the basis of imports set off against it
in the manner defined in the preceding subparagraphs.

The Member States shall periodically inform the Commission of imports effected in accordance with the above rules; such information shall be supplied under the conditions laid down in paragraph 4.

3. As soon as the ceilings have been reached, the Commission may adopt a Regulation reimposing until the end of the calendar year the customs duties applicable to third countries.

In the case of such a reimposition, Greece shall reintroduce the levying of the customs duties which it applies to third countries at the date in question.

However, if customs duties are reimposed, imports of the goods listed in Annex V, which within the meaning of Protocol 2 annexed to the Agreement have obtained originating status in the free zone established by the Agreements signed at Osimo shall continue to benefit from exemption of duties provided that this originating status is certified on the movement certificate by the competent Yugoslav authorities.

4. Member States shall forward to the Commission not later than the 15th day of each month statements of the amounts set off during the preceding month. They shall, if the Commission so requests, make up such statements for periods of 10 days and forward them within five clear days of expiry of the preceding 10-day period.

Article 2

From 1 January to 31 December 1983 imports of the goods originating in Yugoslavia referred to in Annex I for

which the ceiling level is not specified shall be subject to Community supervision.

Member States shall forward to the Commission not later than the 15th day of each month statements of imports of the products in question effected during the preceding month; to this end, only products submitted to the customs authorities under cover of an entry for free circulation and accompanied by a movement certificate conforming to the rules contained in Protocol 2 to the Agreement shall be taken into consideration.

They shall, if the Commission so requests, make up import statements for periods of 10 days and forward them within five clear days of expiry of the preceding 10-day period.

Article 3

The Member States and the Commission shall cooperate closely to ensure that this Regulation is complied with.

Article 4

This Regulation shall enter into force on 1 January 1983.

This Regulation shall be binding in its entirety and directly applicable in all Member
