EXPLANATORY MEMORANDUM

On 11 November 1975 the Commission forwarded a proposal to the Council to amend the three basic regulations on pigmeat, eggs and poultrymeat in respect of the calculation of the levy and the sluice-gate price. It was proposed to reduce from six months to five months the reference period for feed grain prices which is the basis for the calculation of the levies and sluice-gate prices in the three sectors.

To give effect to the provisions set forth in the abovementioned proposal, amendments must also be made to the various regulations laying down the rules for the calculations of these amounts (Regulations (EEC) N° 2764/75, 2766/75, 2773/75, and 2778/75).

Since the entry into force of the amendments to the basic regulations is planned for 1 May 1976, the three regulations amending the rules for calculation should come into force on the same date.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to Council Regulation (EEC) No 2759/75⁽¹⁾ of 29 October 1975 on the common organization of the market in pigmeat, as amended by Regulation (EEC) No ⁽²⁾, and in particular Articles 9 (2) and 12 (4) thereof;

Having regard to the proposal from the Commission;

Whereas Regulation (EEC) No ⁽²⁾ amended Regulation (EEC) No 2759/75 in respect of the reference period for the price of feed grain to be used in calculating the levy and the sluice-gate price of pig carcasses; whereas therefore Council Regulation (EEC) No 2764/75 of 29 October 1975⁽³⁾ laying down the rules for calculating a component of the levy on pig carcasses and Council Regulation (EEC) No 2766/75⁽⁴⁾ of 29 October 1975 establishing the list of products for which sluice-gate prices are to be fixed and laying down the rules for fixing the sluice-gate price for pig carcasses should be amended,

HAS ADOPTED THIS REGULATION :

Article 1

The words "of six months" in Article 3 (2) of Regulation (EEC) No 2764/75 and in Article 2 (3) of Regulation (EEC) No 2766/75 are hereby deleted.

HAS ADOPTED THIS REGULATION :

Article 1

The words "of six months" in Article 3 (2) and in Article 4 (3) of Regulation (EEC) No 2773/75 and in Article 3 (2) and in Article 4 (3) of Regulation (EEC) No 2778/75 are hereby deleted.

Article 2

This Regulation shall enter into force on 1 May 1976.
