EXPLANATORY STATEMENT

- 1. In the course of 1975 the Community adopted various measures regarding rules for imports into the Federal Republic of Germany, the Benelux countries and France of synthetic socks originating in Taiwan.
- 2. Since the factors which justified the institution of these measures are still present, the Commission proposes to the Council that the latter adopt rules for imports which would be applicable until 31 December 1977, the date up to which rules for imports of ther textile products from Taiwan have been established (1).

THE COUNCIL OF THE EUROPEAN COMMUNITIES.

Having regard to the Treaty establishing the European Boonomic Community
Having regard to Council Regulation (EEC) No 1139/74⁽¹⁾ of 1 June 1974 on
common rules for imports, and in particular Article 13 thereof;

Having regard to the proposal from the Commission;

Whereas by Regulation (EEC) No 1413/75 (2) the Commission established a system of authorisations for imports into the Federal Republic of Germany and the Benelux countries of synthetic socks originating in Taiwan and by Regulation (EEC) No 1782/75 (3) the Council maintained that system in effect and by Regulation (EEC) No 175 (4) the Commission extended it until 31 December 1975;

Whereas by Regulation (EEC) No 2930/75⁽⁵⁾ the Commission established interim protective measures with regard to imports of those products into France;

Whereas the factors which justified the establishment of these measures still exist and rules should therefore be adopted to apply until 31 December ... 1977, the date until which rules for imports of certain other textiles products apply (6),

HAS ADOPTED THIS REGULATION:

Article 1

The importation into the Federal Republic of Cermany, the Benelux countries and France of synthetic socks originating in Taiwan shall remain subject until 31 December 1977 production of an import authorisation issued by the competent authorities in these countries.

The total quantity of those products for which import authorisations shall be issued in the Federal Republic of Germany, the Benelux countries and France shall be as follows:

- for the Federal Republic of Germany :

12.28 million pairs for 1976

13.52 million pairs for 1977

- for the Benelux countries:

1.52 million pairs for 1976

1.56 million pairs

for 1977

- for France:

400,000 pairs for 1976

410,000 pairs for 1977

Article 2

This Regulation shall enter into force on 1 January 1976. It shall apply until 31 December 1977.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
