EXPLANATORY MEMORANDUM

By Regulation (EEC) N° 2017/81 of 15 July 1981 the Commission imposed a provisional anti-dumping duty on phenol originating in the United States of America. The maximum period of validity of this measure is four months and the Community's Anti-dumping Regulation (EEC). N° 3017/79 requires the Commission to submit a proposal, either for definitive measures or for an extension of the duty, to the Council not later than one month before the expiry of the provisional measure.

Since the imposition of the duty the Commission's services have continued their examination of this matter. Due to the complexity of this investigation and to the fact that certain American exporters have only recently expressed their willingness to cooperate with the Commission's services in the investigation, it has not been possible to complete it and thus to submit a proposal for definitive measures based on the full facts of the case.

The Commission has notified therefore the exporters known to be concerned of the intention to extend the provisional duty for a further period of two months and the exporters representing nearly all ______ of the trade did not object.

In these circumstances, the Commission submits the attached proposal for a Council Regulation extending the provisional anti-dumping duty on phenol originating in the United States of America for a further period not exceeding two months.
